He agrees that that the certificate can only be used at the licensed premises to be known as Beehave Craft Meadery, situated at 431 Kawakawa Road, Kinloch, Taupo, as well as or for any Special licence granted to Beehave Meadery Limited to be able to sell their products as such events as the Taupo Sunday Market or at craft beverage festivals in order to promote their products (this undertaking would be reviewed after the first initial year of the certificate)".
- 6. The activity of producing and selling mead is low risk and accordingly, the application can be dealt with on the papers.
- 7. The application and supporting information satisfies the Committee that the criteria we must have regard to, as set out in Section 222 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 grants the application by **Jay Scott Bennett** for a Manager's Certificate.

The certificate may only be used at the licensed premises to be known as Beehave Craft Meadery, situated at 431 Kawakawa Road, Kinloch, Taupo, as well as or for any Special licence granted to Beehave Meadery Limited to be able to sell their products as such events as the Taupo Sunday Market or at craft beverage festivals in order to promote their products
