

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Louisa Pescini Limited for a new OFF licence pursuant to Section 100 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 94B Omori Road, Omori and known as "Omori Store"

The Application:

This is an application by **Louisa Pescini Limited** for an Off Licence in respect of premises situated at **94B Omori Road, Omori**, known as **Omori Store**. It was formally received by the Taupō District Licensing Committee on 23rd April 2020. The general nature of the business to be undertaken is that of **Grocery Store**.

The application was duly advertised in the Taupo Times newspaper on 17 March 2020 and on 24 March 2020 and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

Reasons for the Decision:

The applicant appears to be a suitable entity to operate an OFF Licence and has been operating compliantly under Temporary Authority.

The Police and Medical Officer of Health reports raise no matters in opposition.


The petrol business has been retained by the property owner and we are satisfied that the business will operate as a genuine grocery store. Only beer, wine and cider may be sold under this licence.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant an Off Licence authorising the sale and supply of alcohol for consumption off the premises.

The licence shall be subjected to specific conditions as detailed in the attached licence.

OFF LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Louisa Pescini Limited** is authorised to sell or deliver alcohol on or from the premises situated at 94B Omori Road, Omori, and known as Omori Store, **to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.**

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on the premises for consumption off the premises, and supplied free as a sample for consumption on the premises, only on the following days and hours:
Monday to Sunday from 8.00am to 8.00pm.
2. No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00pm on Anzac Day.
3. While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
4. No alcohol may be sold other than –
 - a. beer that complies with the applicable New Zealand food standard for beer; or
 - b. mead that complies with the applicable New Zealand food standard for mead; or
 - c. fruit or vegetable wine that complies with the applicable New Zealand food standard for fruit or vegetable wine; or
 - d. grape wine that complies with the applicable New Zealand food standard for grape wine; or
 - e. a food flavouring, prepared for culinary purposes, that is unsuitable for drinking undiluted.
5. A properly appointed certificated or Acting or Temporary Manager must be on duty, at or nearby the point of sale, at all times when the premises are open for the sale and supply of alcohol.
6. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principle entrance to the premises,
7. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty. The "single alcohol area" for the premises is as described on the plan dated 23 April 2020. The licensee must ensure that:
 - a. No alcohol is displayed, promoted or advertised outside the single alcohol area; and
 - b. No products other than alcohol, low-alcohol and non-alcoholic beer, wine or mead are displayed, promoted or advertised inside the single alcohol area.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises generally. The premises situated at 94B Omori Road, Omori, Turangi, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 23 April 2020.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the carpark off Omori Road is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 26 May 2021 unless further renewed
