IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Wairakei Village Tavern &

Dairy Limited for a new OFF licence pursuant to Section 100 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 5 Rata Street, Wairakei and known as "The Village Public

Bar & Restaurant"

THE APPLICATION:

This is an application by Wairakei Village Tavern & Dairy Limited for an Off Licence in respect of premises situated at 5 Rata Street, Wairakei, known as "The Village Public Bar & Restaurant". It was formally received by the Taupō District Licensing Committee on 7th October 2020. The general nature of the business to be

undertaken is that of Tavern.

The application was duly advertised in the Taupo & Turangi Weekender newspaper on the 22nd and 29th of

October 2020 and no objection or notice of desire to be heard has been received. Display of the public notice

has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections

were lodged by any members of the public.

The Reasons for the Decision:

The sole director of the applicant company has little experience in operating licensed premises however

experienced certificated managerS will be employed to ensure coverage at all times.

The Police and Medical Officer of Health reports raise no matters in opposition.

THE DECISION:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant

an Off Licence authorising the sale and supply of alcohol for consumption off the premises.

The licence shall be subjected to specific conditions as detailed in the attached licence.

OFF LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, <u>Wairakei Village Tavern & Dairy Limited</u> is authorised to sell or deliver alcohol on or from the premises situated at 5 Rata Street, Wairakei, and known as **The Village Public Bar & Restaurant**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied free as a sample for consumption on the premises, only on the following days and hours: On any school day: From 4.00pm to 10.00pm; & On any other day: From 11.00am to 10.00pm.
- 2. No alcohol is to be sold on, or delivered from, the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00pm on Anzac Day.
- While alcohol is being supplied free as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. The whole of the premises are designated as a Supervised Area.
- 5. The Licensee must have available for consumption off the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.
- 7. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol,
 - c. A copy of the licence attached to the inside of the premises so as to be easily read by people entering each principal entrance.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises generally. The premises situated at 5 Rata Street, Wairakei, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 7 October 2020.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCES

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the carpark off Rata Street is designated as the principal entrance.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 12 November 2021 unless further renewed
