Taupo DLC Decision 20/ON/0290/2020

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Big Blue View Limited for a Variation to ON licence pursuant to Section 120 of the Act in respect of the premises situated at Two Mile Bay Reserve, 335 Lake Terrace, Taupo and known as "Two Mile Bay Watersports Centre".

The Application:

This is an application by Big Blue View Limited for a Variation to ON licence in respect of the premises situated at Two Mile Bay Reserve, 335 Lake Terrace, Taupo and known as "Two Mile Bay Watersports Centre." The general nature of the business is that of a Tavern.

The current licensed areas under the On Licence number 020/ON/0290/2020 are the existing kiosk and a roped off outdoor area. The variation is to include a permanently fixed pontoon extending over the lake edge.

The defined areas are more precisely identified on the plan date stamped as received by Taupo District Licensing Committee on 5 June 2020.

The application was publicly notified on council's website for 10 days from the 10th June 2020 and did not attract any objections from the public.

The applicants are proven hospitality operators and experienced managers will control the day-to-day activities.

After a number of discussions and concerns about safety, additional enquiries were undertaken by the Police and Medical Officer of Health. They now report unopposed subject to two new conditions.

Two additional conditions will be added to the licence.

A specific booking must be made to occupy the Pontoon, and the area is not for general use. When in use the pontoon must have one dedicated server allocated to that area.

Table service only with a maximum of ten patrons on the pontoon at any one time.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant a variation to the On Licence authorising the sale and supply of alcohol for consumption on the premises, including the pontoon, to any person who is present on the premises.

The licence will still be subject to the existing conditions plus the two new ones. The expiry date of the licence remains the same i.e. 29 October 2022

ON LICENCE

(for premises)

Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **BIG BLUE VIEW LIMITED** is authorised to sell and supply alcohol, on the premises situated at Two Mile Bay Reserve, 335 Lake Terrace, Taupo and known as "**Two Mile Bay Watersports Centre**", to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: Monday to Sunday from 10.00am to 10.00pm.
- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day to any person other than a person who is on the premises to dine.
- 3. The following parts of the premises are designated as a <u>Supervised Area</u>: <u>The immediate bar counter area.</u>
- 4. A specific booking must be made, and the area is not for general use. When booked the pontoon must have one dedicated server allocated to that area. Table service only with a maximum of ten patrons on the pontoon at any one time.
- 5. The licensed outdoor area must continue to be physically defined with posts and ropes at all times.
- 6. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 7. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 8. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted.
- 9. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
- 10. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 11. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol,
 - c. A copy of the licence attached to the premises so as to be easily read.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised in the premises generally including the outside areas and the pontoon area. The premises situated at Two Mile Bay Reserve, 335 Lake Terrace, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 5 June 2020.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE

A copy of this licence must be displayed at the principal entrance to the premises. The entrance from the verandah into the kiosk area is designated as the principal entrance.

This licence expires on 29 October 2022 unless further renewed
