# The Application:

This is an application by FWD Limited for an On Licence in respect of premises situated at 11 Te Arahori Street, Turangi, known as "ToiToi Food Co". It was formally received by the Taupō District Licensing Committee on 18 July 2019. The general nature of the business to be undertaken is that of a Caterer with a Section 38 endorsement..

The application was duly advertised in the Taupo & Turangi Weekender newspaper on 8 August 2019 and on 15 August 2019, and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

# The Reasons for the Decision:

The applicant is a suitable and experienced entity to hold this caterers endorsed ON Licence. The Food Truck is not' licensed' per sae, the home base is, and the vehicle may be used to facilitate the provision of food and alcohol at private functions and occasions.

For clarity we clearly state that this licence can only be used at an event promoted by someone other than the licensee. It is often said that the first year of a licence is the 'probationary year.'

The Police and Medical Officer of Health reports raise no matters in opposition.

### The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant an On Licence authorising the sale and supply of alcohol for consumption on the premises, to any person who is present on the premises.

The licence shall be subjected to specific conditions as detailed in the attached licence.

#### **ON LICENCE**

(for premises)

Sections 14 to 16, and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **FWD LIMITED** is authorised to sell and supply alcohol, on the premises situated at 11 Te Arahori Street, Turangi and known as "**ToiToi Food Co**" to any person for consumption on the premises and to let people consume alcohol there.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

#### **ENDORSEMENT**

**Section 38 of the Act applies to this licence**. The licensee is authorised to deliver alcohol from the premises and sell it on any other premises for consumption on those premises by people attending a reception, function, or other social gathering promoted by a person or association of people other than the licensee.

## **CONDITIONS**

### The following conditions apply at every venue at which the licensee sells or supplies alcohol pursuant to this licence:

- 1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours:
  - Monday to Sunday from 10.00am to 12.00 midnight.
- 2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day other than a person who is on the premises to dine.
- 3. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises
- 4. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible, and food should be actively promoted.
- 6. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
- 7. The Licensee must provide information, advice and assistance about alternative forms of transport available to patrons from the licensed premises.
- 8. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. At the principal entrance to the premises, so as to be easily read by people immediately outside the premises, a sign stating the ordinary hours of business during which the premises will be open for sale of alcohol,
  - **c.** A copy of the licence attached to the premises so as to be easily read.

## THE LICENSED PREMISES

The premises situated at 11 Te Arahori Street, Turangi, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 5 November 2019.

### **DURATION**

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 7 November 2020 unless further renewed
