**The Application:**

This is an application by Ravinder Kaur for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 25th May 2022.

1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
