The Application:

This is an application by **Unchalee Phunsawan** for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 2nd October 2019.

1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
3. Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the renewal of the certificate. Accordingly, the application can be dealt with on the papers.
4. The application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 approves the application by **Unchalee Phunsawan** for the renewal of a Manager's Certificate.

The Committee notes that the applicant's current Work Visa expires on 31 January 2021. Evidence of a new Visa must be delivered to the Taupo District Licensing Committee before that date for this certificate to remain valid beyond that date.

The certificate is renewed for a further period of three years from the date of expiry of the current certificate.
