The Application:

This is an application by Shayne Dalee Patricia Peden for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 20 February 2020.

- 1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
- 2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
- Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the renewal of the certificate. Accordingly, the application can be dealt with on the papers.
- 4. However, they do report that the applicant was the Duty Manager at Finn's Bistro & Bar on 14 December 2019 when her staff member sold alcohol to a CPO volunteer. A holding has been issued by ARLA and her Managers Certificate suspended for 28 days from 16 February 2020.
- 5. Under Section 227 we are required to have regard to the manner in which the manager has managed the sale and supply of alcohol during the renewal period. Had she been the seller in the CPO she would be looking at final warning and/or a severely truncated renewal. Obviously, any further offending of a similar vein will be dealt with firmly by the agencies.
- 6. Subject to the above, the application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 approves the application by **Shayne Dalee Patricia Peden** for the renewal of a Manager's Certificate.

The certificate is renewed for a further period of three years from the date of expiry of the current certificate.
