The Application:

This is an application by Samphat Janla-Trainor for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 1st October 2021.

- 1. The applicant holds the Licence Controller Qualification and the LCQ Bridging Certificate and is employed in licensed premises.
- 2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
- 3. Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the renewal of the certificate. However, the Police report that the applicant incurred a DIC conviction in February of 2019. Apparently, it was not picked up by the Police and no suspension of the Managers certificate was sought.
- 4. It is now 2 ½ years since the offence and too late to apply for a suspension. We formally record our concern and remind the applicant that we expected certificated managers to set the example for their patron and not drink to excess and drive motor vehicles.
- 5. Subject to the above, the application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 approves the application by **Samphat Janla-Trainor** for the renewal of a Manager's Certificate.

The certificate is renewed for a further period of three years from the date of expiry of the current certificate.
