

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012

**AND**

**IN THE MATTER** of an application by The Tokaanu-Turangi & Districts Memorial RSA Incorporated for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **24 Katopu Street, Turangi** and known as "**Tokaanu-Turangi & Districts Memorial RSA**".

**THE APPLICATION**

This is an application by **The Tokaanu-Turangi & Districts Memorial RSA Incorporated** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Tokaanu-Turangi & Districts Memorial RSA**, situated at **24 Katopu Street, Turangi**.

The applicant is the holder of an **Off Licence** 020/OFF/0021/2015 which was last renewed by the Taupo District Licensing Committee on the 10<sup>th</sup> of June 2016.

The application was duly advertised on the Taupo District Council website from 10 December 2018 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

We agree that there need not be a condition requiring that a certificated manger be on duty at all times, but we certainly expect one to be on duty at the busy times each day.

**REASONS FOR THE DECISION**

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

**THE DECISION**

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on refreshed conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.

### **Notice of Renewal of Off Licence**

*Section 135, Sale and Supply of Alcohol Act 2012*

The Off Licence in respect of the premises situated at 24 Katopu Street, Turangi known as “**Tokaanu-Turangi & Districts Memorial RSA**” is renewed.

The refreshed conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

**The licence is renewed for three years and expires on 23 December 2021.**
