THE APPLICATION

This is an application by **Moss Food Barn Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Foodworld Four Square**, situated at **106 Rifle Range Road**, **Taupo**.

The applicant is the holder of a **Off Licence** [Licence Number 20/OFF/0086/2017] which was last renewed by the Taupō District Licensing Committee on 1st November 2017.

The application was duly advertised on the Taupo District Council website from 3 September 2020 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

We are satisfied that the alcohol is displayed in a compliant Single Alcohol Area and that the business operates as a genuine grocery store.

THE DECISION

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued containing an additional condition relating to the provision of free drinking water.
