

IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by 5 Mile Distilling Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **2 Pukenuamu Road, Taupo** and known as "**5 Mile Distilling**".

THE APPLICATION

This is an application by **5 Mile Distilling Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **5 Mile Distilling**, situated at **2 Pukenuamu Road, Taupo**.

The applicant is the holder of a **Off Licence** [Licence Number 20/OFF/0114/2022] which was first granted by the Taupō District Licensing Committee on 8th April 2022.

The application was duly advertised on the Taupo District Council website from 17 January 2023 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for the last 12 months.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the social responsibility practices appear sound.

We amend Condition 1 to allow the wider delivery hours as permitted in the Act and captured in condition 3.

Condition 2 has been adjusted to make it clearer.

No alcohol is to be delivered from the premises on Good Friday, Easter Sunday or Christmas Day or before 1.00pm on Anzac Day. Sales can still be made from the premises on the sacrosanct days.

THE DECISION

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for 3 years on the amended conditions as set out on the attached replacement licence.

I direct that a notice of renewal and a replacement licence be issued.

Notice of Renewal of Off Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **5 Mile Distilling Limited**

Licence **20/OFF/0114/2023** replacing licence **20/OFF/0114/2022**

The Off Licence in respect of the premises situated at 2 Pukenamu Road, Taupo known as “**5 Mile Distilling**” is renewed.

The amended conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 8 April 2026.
