**THE APPLICATION**

This is an application by **The Merchant of Taupo 2007 Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **The Merchant of Taupo**, situated at **114 Spa Road, Taupo**.

The applicant is the holder of an **Off Licence** 020/OFF/0063/2011 which was last issued by the Taupo District Licensing Committee on the 4 November 2011.

The application was duly advertised on the Taupo District Council website from 11 October 2018 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

**REASONS FOR THE DECISION**
