The Application:

This is an application by Taupo NZ Limited for the renewal of an **On Licence** in respect of the licensed premises known as **Mulligans Public House**, situated at **15 Tongariro Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 11th May 2019.

The applicant is the holder of an **On Licence** 020/ON/0191/2018 that was last renewed by the Taupo District Licensing Committee on 12 October 2018.

The application was duly advertised on the Taupo District Council website from 13 May 2019 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Reasons for the Decision:

The applicant appeared before the Taupo DLC in 2018 following adverse reports relating to intoxication and management issues. A truncated renewal was approved, and the applicant was put on notice to lift their game around these concerns.


It is pleasing to see that both the Police and the Inspector report an improved performance by Mr. Contractor and his team. On that basis we can consider a renewal on the papers.

A renewal of licence is never to be considered a forgone conclusion and at every renewal time the application for a licence is considered afresh.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

Notice of Renewal of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **Taupo NZ Limited**

Licence **20/ON/0191/2019** replacing licence **20/ON/0191/2018**

The On Licence in respect of the premises situated at 15 Tongariro Street, Taupo known as “**Mulligans Public House**” is renewed.

The present conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 9 July 2022.
