## **DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE**

## The Application

This is an application by **Villa Italia Limited** for an Off-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Taupo Home and Garden Show 2020.** It was formally received by the Taupō District Licensing Committee on 15th January 2020.

#### **Reasons for the Decision**

Friday 3 April 2020; Saturday 4 April 2020 and Sunday 5 April 2020 from 10.00am to 5.00pm on each day.

- 2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- A certificated manager must be on duty at all times, within the licensed area, when the premises are
  open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in
  the stall.
- 4. The Licensee must display:

- a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
- b. A copy of the licence is to be attached to the stand so as to be easily read by people attending the licensed area.
