The Application:

This is an application by Tongariro Junction Limited for the renewal of an **On Licence** in respect of the licensed premises known as **Tongariro Junction**, situated at **25 Ohuanga Road**, **Turangi**. It was formally received by the Taupō District Licensing Committee on 27th January 2021.

The applicant is the holder of a **On Licence** [20/ON/0321/2020] which was first granted by the Taupō District Licensing Committee on 29th January 2020.

The application was duly advertised on the Taupo District Council website from 28th January 2021 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Reasons for the Decision:

The applicant has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

However, there is currently no certificated manager appointed to the business and no alcohol can be sold to the in-house guests while this situation remains.

The applicant must source an experienced certificated manager to be appointed to the premises.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and we approve a renewal of the On Licence authorising the sale and supply of alcohol for consumption on the premises, to any in-house guests who are lodging on the premises.

I direct that a notice of renewal and a replacement licence be issued.
