The Application:

This is an application by Waterside Taupo Limited for the renewal of an **On Licence** in respect of the licensed premises known as **Waterside Restaurant & The Deck**, situated at **1 Tongariro Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 17th June 2021.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0210/2018] which was last renewed by the Taupō District Licensing Committee on 18th July 2018.

The application was duly advertised on the Taupo District Council website from 18th July 2021 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

The agencies have recommended that there be a condition requiring a certificated manager to be on duty on the ground floor and another upstairs on the Deck area. The applicant has consented to this addition. The Committee agrees with the rationale and imposes the condition.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on amended conditions.
