IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by Lion Liquor Retail Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **150 Acacia Bay Road, Taupo** and known as "**Liquor King Nukuhau**".

THE APPLICATION

This is an application by **Lion Liquor Retail Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Liquor King Nukuhau**, situated at **150 Acacia Bay Road**, **Taupo**.

The applicant is the holder of a **Off Licence** [Licence Number 20/OFF/0027/2018] which was last renewed by the Taupō District Licensing Committee on 9th October 2018.

The application was duly advertised on the Taupo District Council website from 23 August 2021 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

Neither the Police nor the Medical Officer of Health oppose the approval of the renewal. However, the MOoH 'recommend' that suite of conditions as imposed on a bottle store in Timaru be added to the licence. There is no supporting information linking the Timaru application and this one, nor is there any information submitted that the discretionary conditions are relevant and should be included.

Discretionary conditions are particularly case specific, and they will not be imposed in this renewal.

THE DECISION

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.
