The Application:

This is an application by Yum Food Company Limited for the renewal and variation of an **On Licence** in respect of the licensed premises known as **The Brantry Restaurant**, situated at **45 Rifle Range Road, Taupo**. It was formally received by the Taupō District Licensing Committee on 10th November 2021.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0072/2021] which was last renewed by the Taupō District Licensing Committee on 21st January 2019.

The application was publicly notified in the “Taupo Times” newspaper on 19 November 2021 and on 26 November 2021. There was also a notice placed on the exterior of the premises during this time. The application did not attract any objections from the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

We approve the variation of the licensed area as displayed on the plan dated 9 November 2021

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on amended conditions.

Notice of Renewal and Variation of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **Yum Food Company Limited**

Licence **20/ON/0072/2021** replacing licence **20/ON/0072/2018**

The On Licence in respect of the premises situated at 45 Rifle Range Road, Taupo known as “**The Brantry Restaurant**” is renewed.

The amended conditions of the licence now apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed for three years and expires on 12 December 2024.
