IN THE MATTER of an application by Thai Central Limited for the variation of an ON licence pursuant to Section 120 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at 45 Ruapehu Street, Taupo and known as “**Thai Central Restaurant**”

The Application:

This is an application by Thai Central Limited for the variation of an **On Licence** in respect of the licensed premises known as **Thai Central Restaurant**, situated at **45 Ruapehu Street, Taupo**. It was formally received by the Taupō District Licensing Committee on 16th February 2022.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0361/2021] which was first granted by the Taupō District Licensing Committee on 22 October 2021.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for the last 6 months and recommends that the licensed area be varied to include the outdoor area on the footpath.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The request to increase the licensed area is reasonable and the host responsibility practices appear sound.

The new licensed area is that described in the new plan dated 24 February 2022.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the variation on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of variation and a replacement licence be issued. The expiry date remains the same.

Notice of Variation of On Licence

Section 120, Sale and Supply of Alcohol Act 2012

To: **Thai Central Limited**

Licence **20/ON/0361/2021**

The On Licence in respect of the premises situated at 45 Ruapehu Street, Taupo known as “**Thai Central Restaurant**” is varied

The present conditions of the licence shall continue to apply.
