The Application:

This is an application by Karena Joy Colle & Ettore Colle, trading in partnership, for the renewal and variation of an **On Licence** in respect of the licensed premises known as **Valentino’s Licensed Italian Restaurant**, situated at **76 The Town Centre, Turangi**. It was formally received by the Taupō District Licensing Committee on 1st June 2022.

The applicant is the holder of a **On Licence** [Licence Number 20/ON/0082/2019] which was last renewed by the Taupō District Licensing Committee on 15th July 2019.

The application was duly advertised on the Taupo District Council website from 7th June 2022 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

The Reasons for the Decision:

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

By consent the hours are varied to 11.00am to 11.00pm to more align with the operation of the business.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on conditions varied from those previously granted by the Taupo District Licensing Committee.

Notice of Renewal of On Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: **Karena Joy Colle & Ettore Colle**

Licence **20/ON/0082/2022** replacing licence **20/ON/0082/2019**

The On Licence in respect of the premises situated at 76 The Town Centre, Turangi known as “**Valentino`s Licensed Italian Restaurant**” is renewed.

The varied conditions of the licence shall apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.

The licence is renewed and varied for three years and expires on 2 June 2025.
