DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **Dawn McClay for NZ National Party Taupo** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **Luncheon of NZ National Party with Hon Nicki Kaye MP.** It was formally received by the Taupō District Licensing Committee on 12th July 2019.

- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

- b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
- c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
- d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

The licensed premises known as the National Party Luncheon with Hon. Nicki Kaye MP situated at Rotary House, 12 Story Place, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 12 July 2019.

Section 22 and 64, Sale and Supply of Alcohol Act 2012
