## **DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE**

### The Application

This is an application by **Greenstone Entertainment GP Limited** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **2020 Taupo Summer Concert.** It was formally received by the Taupō District Licensing Committee on 26th June 2019.

#### **Reasons for the Decision**

The applicant is an experienced operator and has promoted and managed similar concerts for several years in Taupo largely without incident in recent times.

Initial concerns held by the Police and MOoH have been discussed and debated for several months and modifications and concessions have been made.

We congratulate all parties on the work they have put in to the discussions and the 'resolution.'

The final reports of the Police and the Medical Officer of Health do not oppose this application.

However, as we have told Mr and Mrs Calvert several times before, their good record of compliance must never be taken for granted or relied upon, and ongoing attention to detail and supervision must occur to protect their suitability to hold such a permissive licence now and in the future.

We believe the initiative to have some security shadow concert goers in to town is a good one as they will create a visual presence. As acknowledged, they will have no powers to intervene if disorderly behaviour occurs but will be able to point out offenders to police or the town premises security officers.

#### The Decision

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

- 1. Alcohol may be sold and supplied for consumption on the premises only on the following day and hours: Saturday 25 January 2020 from 10.30am to 5.20pm (Public bars) and from 11.00am to 5.30pm (Corporate Bar).
- 2. Drinking water must be freely available at both public bars, and at the corporate area bar. Two large "water tanker trucks" shall be located at either side of the venue, with taps available on each truck for patrons to access free drinking water.

- 3. A certificated manager must be on duty at all times at each bar facility, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menus supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 6. Only beer, alcoholic cider and wine will be sold at the event, no Ready to Drink (RTD) products or freepour spirits. Beer and Cider is to be sold in cans and bottles; and wine will be sold in glass bottles with plastic cups.
- 7. Beer cans and bottles are to be de-pressurised at point of sale from 2.30pm.
- 8. The Licensee must display signage as follows:
  - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty at each bar facility.
- 9. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- 10. The licence is also subject to the following conditions, which in the committee's opinion are not inconsistent with the Act:
- 11. <u>Alcohol serves: Public bars</u> a Maximum of Four Beers/ Ciders and One 750ml bottle of Wine can be sold to one person at any one time from 10.30am to the reduction time of 2.30pm. From 2.30pm this will reduce to two plastic glasses of wine or two cans/glasses of beer or cider until both bars close at 5.20pm.
- 12. <u>Alcohol serves: Corporate Bar</u> a Maximum of Four Beers/ Ciders and One 750ml bottle of Wine can be sold to one person at any one time from 11.00am to the reduction time of 2.30pm. From 2.30pm this will reduce to two plastic glasses of wine or two cans/bottles of beer or cider until the bar closes at 5.30pm.
- 13. A One-Way Door (OWD) Policy shall apply and no Pass Outs are to be permitted, except on medical grounds.
- 14. Police have the ability to change alcohol service sizes, or to close all or any bar at any time based around crowd behaviour, or to change the time of depressurisation of cans & bottles to earlier in the day. These decisions will be based on review meetings with officers of Greenstone Entertainment GP Limited, any of the regulatory agencies present and the Concert Promoters.

The licensed premises known as the 2020 Taupo Summer Concert situated at Taupo Amphitheatre, Riverside Park, 11 Redoubt Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 26 June 2019.

# Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **Greenstone Entertainment GP Limited** is authorised to sell and supply alcohol, on the premises situated at Riverside Park, Redoubt Street, Taupo, and known as Taupo Ampitheatre, Riverside Park, 11 Redoubt Street, Taupo for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **2020 Taupo Summer Concert.** 

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### **Conditions:**

This licence is subject to the following conditions:

- 1. Alcohol may be sold and supplied for consumption on the premises only on the following day and hours: Saturday 25 January 2020 from 10.30am to 5.20pm (Public bars) and from 11.00am to 5.30pm (Corporate Bar).
- 2. Drinking water must be freely available at both public bars, and at the corporate area bar. Two large "water tanker trucks" shall be located at either side of the venue, with taps available on each truck for patrons to access free drinking water.
- 3. A certificated manager must be on duty at all times at each bar facility, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menus supplied with the application for this licence, or menu variations of a similar range and standard.

These decisions will be based on review meetings with officers of Greenstone Entertainment GP Limited, any of the regulatory agencies present and the Concert Promoters.

#### **Duration**

This licence is only in force as specified in Condition 1.
