DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **Taupo Bowling Club Incorporated** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for **5 Birthday Parties over the coming 3 months.** It was formally received by the Taupō District Licensing Committee on 19th August 2020.

Reasons for the Decision

The applicant is a suitable entity to hold a Special Licnece and certificated managers will oversee the sale, supply, and consumption of alcohol. As agreed, we will impose a two drink per sale condition on the 2 higher risk events.

The reports of the Police and the Medical Officer of Health do not oppose this application.

The Decision

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

 Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

Saturday 19 September 2020 from 6.00pm to 11.30pm (Birthday Function for Tessa Richardson); Saturday 24 October 2020 from 6.00pm to 11.30pm (Birthday function for Warren Brickell); Saturday 31 October 2020 from 6.00pm to 11.30pm (50th Birthday function for John Taylor); Saturday 7 November 2020 from 6.00pm to 11.45pm (21st Birthday function for Jaxxon Phillips); Saturday 28 November 2020 from 6.00pm to 11.45pm (Birthday function for Darnell Williams).

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.

- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. There will be a limit of two serves of alcohol per transaction for the following events:

Saturday 7 November 2020 from 6.00pm to 11.45pm (21st Birthday function for Jaxxon Phillips); & Saturday 28 November 2020 from 6.00pm to 11.45pm (Birthday function for Darnell Williams).

- 6. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 7. The Licensee must display signage as follows:
 - a. At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
