## The Application

- A certificated manager must be on duty at all times, within the licensed area, when the premises are
  open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in
  the stall.
- 4. The Licensee must display:
  - At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

b. If so directed a copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.
