DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **The Rogue Bore Limited** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **New Years Eve function 2021.** It was formally received by the Taupō District Licensing Committee on 2nd December 2020.

Reasons for the Decision

The applicant appears to be a responsible licensee and has agreed to a number of discretionary conditions for this event.

We remind the applicant that we made it clear when first granting the ON Licence that they must 'fly under the radar' due to the unique circumstances surrounding this site.

The reports of the Police and the Medical Officer of Health do not oppose this application.

The Decision

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

- The issue of the licence shall be subject to the following conditions: Alcohol may be sold and supplied
 for consumption on the premises only on the following days and hours: Thursday 31 December from
 3.30pm to 2.00am the following day the sale of alcohol is to cease at 1.30am, and the premises
 must be vacated by 2.00am on 1 January 2021.
- 2. A maximum of two alcoholic drinks per person per serve.
- 3. The entire licensed area is to be designated as a Restricted area.
- 4. A one-way door policy is to be in force from 12.30am on 1 January 2021.
- 5. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.

6. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.

7. Food must be available for consumption on the premises at all times the premises are open for the

sale and supply of alcohol, in accordance with the sample menu supplied with the application for this

licence, or menu variations of a similar range and standard.

8. The licensee must have available for consumption on the premises, at all times when the premises

are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol

beverages.

9. The Licensee must display signage as follows:

a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and

intoxicated persons,

b. A copy of the licence attached to the premises so as to be easily read by persons attending the

premises,

c. A sign prominently displayed at the premises, which identifies by name the manager for the time

being on duty,

d. The licensee must provide information and advice about forms of transport available to patrons

from the licensed premises.

The licensed premises known as The Rogue Bore situated at 29 Tuwharetoa Street, Taupo, is more precisely

identified as outlined in the event site plan provided with the application, as received by the Taupo District

Licensing Committee on 2 December 2020.

Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **The Rogue Bore Limited** is authorised to sell and supply alcohol, on the premises situated at 29 Tuwharetoa Street, Taupo, and known as The Rogue Bore for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **New Years Eve function 2021.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

Conditions:

This licence is subject to the following conditions:

- 1. The issue of the licence shall be subject to the following conditions: Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: Thursday 31 December from 3.30pm to 2.00am the following day the sale of alcohol is to cease at 1.30am, and the premises must be vacated by 2.00am on 1 January 2021.
- 2. A maximum of two alcoholic drinks per person per serve.
- 3. The entire licensed area is to be designated as a Restricted area.
- 4. A one-way door policy is to be in force from 12.30am on 1 January 2021.
- 5. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 6. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 7. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 8. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
- 9. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

Duration

This licence is only in force as specified in Condition 1.

The licensed premises known as The Rogue Bore situated at 29 Tuwharetoa Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 2 December 2020.
