DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **The Merchant of Taupo 2007 Limited** for an OFF-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **The Merchant and Scenic Cellars Wine, Craft Beer & Food Expo**. It was formally received by the Taupō District Licensing Committee on 21st July 2021.

Reasons for the Decision

The applicant is a responsible entity to hold a Special Licence and certificated managers will oversee the sale, tasting and consumption of alcohol.

The reports of the Police and the Medical Officer of Health do not oppose this application.

The Decision

I am satisfied that the criteria of Section 142 of the Sale and Supply of Alcohol Act 2012 have been satisfactorily addressed by the applicant and the licence may issue subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:
Wednesday 18 August 2021 from 5.00pm to 10.30pm (from 5.00pm to 9.00pm for the Public Expo; and from 9.00pm to 10.30pm for the Exhibitors & staff tastings).
2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. All samples provided to attendees must be a maximum of 15 mls or under whilst this licence is in operation from 5.00pm to 10.30pm.

4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in at the venue.

5. The duty manager's must be roaming around the venue to monitor those who are sampling alcohol at all stalls, as well as monitoring intoxication levels and preventing guests from becoming intoxicated.

6. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

 - b. If so directed a copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

The licensed premises known as The Merchant and Scenic Cellars Wine, Craft Beer & Food Expo situated at The Great Lake Centre 28 Tongariro Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 21 July 2021.

Taupo District Licensing Committee Special Licence – Off Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **The Merchant of Taupo 2007 Limited** is authorised to sell and supply alcohol, on the premises situated at The Great Lake Centre, 28 Tongariro Street, Taupo, for consumption OFF the premises, to any person attending the following occasion or event (or series of occasions or events): **The Merchant and Scenic Cellars Wine, Craft Beer & Food Expo.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

Conditions:

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours:
Wednesday 18 August 2021 from 5.00pm to 10.30pm (from 5.00pm to 9.00pm for the Public Expo; and from 9.00pm to 10.30pm for the Exhibitors & staff tastings).
2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
