DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **Begin Distilling Limited** for an Off-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **The Taupo Home & Garden Show 2022**. It was formally received by the Taupō District Licensing Committee on 4th March 2022.

Reasons for the Decision

The applicant is a responsible entity to be granted a Special licence and certificated managers will oversee the on-site tastings, and sales of bottles of Gin, for off-site consumption.

Friday 29 April 2022 from 10.00am to 5.00pm; Saturday 30 April from 10.00am to 5.00pm; & Sunday 1 May 2022 from 10.00pm to 4.00pm.

- 2. A maximum of three tasting samples of 5ml each, per person, are permitted
- 3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed at the stand (number 232).
- 5. The Licensee must display:

- a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
- b. If so directed a copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

The licensed premises situated at Stand 232 at The Great Lake Centre, 30 Tongariro Street, Taupo, is more precisely identified as outlined in the "Taupo Home & Garden Show 2022 Site Plan" provided with the application, as received by the Taupo District Licensing Committee on 4 March 2022.
