

## Taupo District Licensing Committee Special Licence – On Site

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Endeavour Live Limited** is authorised to sell and supply alcohol, on the premises situated at Riverside Park, Redoubt Street, Taupo, and known as Riverside Park, Taupo for consumption on the premises, to any person attending the following occasion or event: **Fat Boy Slim concert.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

### Conditions:

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: **Sunday the 5th of February 2023 from 6.00pm to 10.30pm with the sale of alcohol to cease at 10.00pm.**
2. Drinking water must be freely available at all bars, and within the licensed area with taps available for patrons to access free drinking water and clean disposable cups.
3. A certificated manager must be on duty at all times at **each bar facility**, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be prominently displayed.
4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menus supplied with the application for this licence, or menu variations of a similar range and standard.
5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a **reasonable range** of non-alcoholic and low-alcohol beverages.
6. Alcohol may be sold in the following types of containers only: **All drinks to be sold in depressurised cans or plastic goblets/cups.**
7. A **One-Way Door (OWD) Policy shall apply at all times and no Pass-Outs** are to be permitted (other than for medical reasons);
8. The Licensee must display signage as follows:
  - a) At every point of sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b) A copy of the licence attached to the premises so as to be easily read by persons attending the premises;
9. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
10. **Alcohol serves: - a Maximum of Four Beers/Ciders/RTDs or plastic glasses of wines can be sold to one person at any one time from 6.00pm to the reduction time of 8.30pm. From 8.30pm the serve size will reduce to two plastic glasses of wine OR two cans of beer, RTDs or cider until all bars close at 10.00pm. (also subject to Condition 12);**
11. **Cocktails may be sold in the VIP area subject to the restrictions in Condition 10. In addition, a drinks menu is to be prominently displayed at the VIP Bar that clearly shows to patrons, the alcohol content of all drinks to be sold. Cocktails are to be dispensed in a plastic vessel containing no more than 375mls at 5% abv.**
12. **Police have the ability to require the further reduction of alcohol serve sizes, or to request a closure of all, or any bar, at any time based on crowd behaviour. This request is to be evidence-based on hourly review meetings with Endeavour Live Limited, the Taupo Police, the Taupo Licensing Inspector, the Medical Officer of Health Representative (if present).**

### Duration

This licence is only in force as specified in Condition 1.

The licensed premises known as "Riverside Park, Taupo" situated at Riverside Park, Redoubt Street, Taupo, is more precisely identified as outlined in the "Event site plan" provided with the application, as received by the Taupo District Licensing Committee on 30th November 2022.
