The Application

This is an application by The Cocktail Shop Limited for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Market Central Taupo. It was formally received by the Taupō District Licensing Committee on 2nd November 2023.

Reasons for the Decision

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.

The Police and Medical Officer of Health reports raise no matters in opposition.

The Decision

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): Market Central Taupo.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **The Cocktail Shop Limited** is authorised to sell and supply alcohol, on the premises situated at Northcroft Street and known as Northcroft Reserve Taupo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Market Central Taupo**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: **Sunday 26 November 2023; Sunday 3, 10, 17 & 24 December 2023; Sunday 7, 14, 21 & 28 January 2024; Sunday 4 February 2024; Sunday 3 & 31 March 2024; Sunday 14, 21 & 28 April 2024. From 9.00am to 1.00pm on each date.**
2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
4. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the stall so as to be easily read by persons attending the licensed area.

DURATION

This licence is only in force as specified in Condition 1.

THE LICENSED PREMISES

The licensed premises known as The Cocktail Shop/ First Class Cocktails situated at Taupo Market Central, situated at Northcroft Reserve, Northcroft Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 2 November 2023.
