The Taupo District Licensing Committee have approved a Temporary Authority for the premises known as The Local Diner, situated at 140 Napier Road, Taupo. This Temporary Authority is valid for a period of 3 months from 13 January 2024 to 13 April 2024.

A Temporary Authority is an interim approval for licensees pending approval of a new premises licence. It grants authority to sell and supply alcohol under the previous licence held by the business. As such it is subject to the same conditions as well as any additional conditions imposed by the committee. It is important that the applicant is aware of these conditions and adheres to them including the licenced days and hours.

This Temporary Authority is required to be displayed where it can be easily read by the public, adjacent to the substantive licence in force. A copy of this Temporary Authority has also been sent to the New Zealand Police.

Enclosed is the floor plan showing the licensed area(s).

It is strongly recommended that holders of a Temporary Authority make an application as soon as possible for a new licence, as this process can take up to six weeks. Applicants failing to make an application for a new licence in a timely manner are unlikely to be granted an extension of this Temporary Authority and will not be permitted to sell alcohol past the expiry date.

This is an application by Spicy Touch Limited for a Temporary Authority for a premises situated at 140 Napier Road, Taupo to be known as The Local Diner.

There is a substantive Temporary Authority in place with the licence number 20/ON/0341/2021 that expires on 25 November 2024.

The application contains supporting documentary evidence indicating that a Sale & Purchase/ Lease agreement has been completed for the business.

REASONS FOR THE DECISION

Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the granting of the order.

THE DECISION

The application and supporting information satisfies us that the criteria we must have regard to as set out in s.136 of the Act has been met.

Section 136(5) of the Act says the person authorised by the order has for the purposes of this Act the same duties, obligations, and liabilities as the holder of the on-licence or off-licence concerned.

The District Licensing Committee, acting pursuant to the Sale and Supply of Alcohol Act 2012 makes an order for a Temporary Authority Temporary Authority with the existing conditions on the base licence continuing to apply.
