Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Amanda Christina Smith** is authorised to sell and supply alcohol, on the premises situated at Northcroft Street and known as Market Central Taupo, Nothcroft Reserve, Taupo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Market Central Taupo.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold and supplied for consumption only on the following days and hours:
 - Every Sunday from 5 May 2024 to 14 July 2024, Every Sunday from 25 August 2024 to 20 October 2024. Also Saturday 26 October 2024. From 9.00am to 1.00pm on each date.
- 2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the stall so as to be easily read by persons attending the licenced area.

DURATION

This licence is only in force as specified in Condition 1.
