Feedback and results are grouped into the topic areas of the online survey, and then by graphical area by topic.

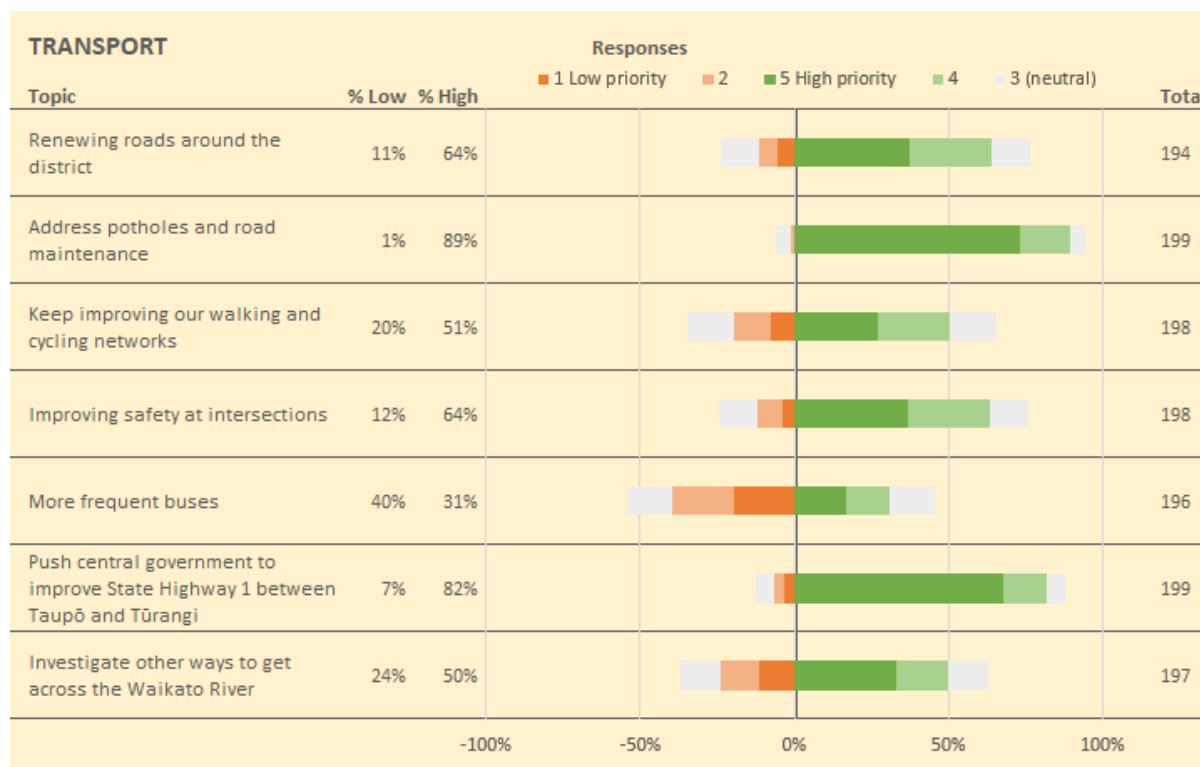
There has been minor editing of feedback to support legibility and remove obscenities and names. Some feedback provided are notes taken by staff to reflect feedback from conversations at the engagement events.

## TRANSPORT



### RENEWING ROADS AROUND THE DISTRICT / ADDRESS POTHOLES AND ROAD MAINTENANCE

- Fix your potholes.
- Fix the potholes please.
- The low quality of road building is the primary problem. You get what you pay for. A better initial build quality means less maintenance, and less rates. Your caution above is uncalled for. Stop accepting the lowest bid. The roading industry is perfectly capable of building a good road if you want them to. The bypass is an excellent example of these points.

The Second major issue is number and weight of trucks. The damage they cause is significant. As it is the Govt who calls for more, bigger, and heavier trucks, it is the Govt who should fund that additional cost via a heavy transport industry levy.

- But don't get OPUS / WSP to do any work, they have wasted many many dollars of Taupō Ratepayers. EG- Wrong size roundabouts x 3 Taupō ETA, Mastic Foam Road Surface Taupō ETA (Lasting 50 years was the quote in the Taupō Times), Wrong Paint System used on the new Wairakei River Bridge. WSP/OPUS are [incompetent].
- Why should this increase our rates when road maintenance is included in the rates we already pay. Maybe fixing the potholes etc properly the first time especially in high trafficked roads and where potholes are prone to developing would be more cost effective than doing a botch fill in job that lasts a week or 2 if we're lucky! This is especially important in higher speed areas.
- How about you guys start holding the roading companies to account. If their work is not up to standard or fails within a window of time. They get held accountable with a large fine. And viola in a years' time our roads will be back to a safe standard.
- Employ companies that have the experience, expertise & equipment to complete road maintenance and resurfacing with maximum efficiency - and to such a standard that it will last for years. Taupō ratepayers are disillusioned & furious that our roads are repeatedly repaired by 2 or 3 workmen, with shovels (like 3rd world countries) dozens of road cones - and it takes weeks! Please investigate how modern European countries build & repair roads and consider importing the expertise and equipment to make this happen in New Zealand.



- How much more money will you let the uneducated people plan road that don't work and [muck] it up so bad that you have to do the same job twice, you should be fired.

### **KEEP IMPROVING OUR WALKING AND CYCLING NETWORKS**

- We should be prioritising cycle lanes. Many roads in Taupō either have non-existent cycle lanes or lanes that have parked cars, broken glass or potholes.
- Developing safe cycle and walking options for children to school and town must be a top priority over spending money on roads - obviously for safety and health reasons, but also so that kids can be more self-sufficient and not rely on caregivers clogging up the roads with their cars at pick up and drop off times, puts less stress on roads, and kids need to be safe cycling and walking to and from school and town. Safety at intersections must be cycle and walking safe.
- Safe cycling/walking routes to every school is paramount. Safe cycling/walking routes & crossings into shopping areas.
- More pedestrian crossing around town.

### **IMPROVING SAFETY AT INTERSECTIONS**

### **MORE FREQUENT BUSES**

- More frequent public transport -electric - reduce carbon emissions across district.
- Instead of busses which are frequently empty, use mini busses as are used in most other countries.

### **PUSH CENTRAL GOVERNMENT TO IMPROVE STATE HIGHWAY 1 BETWEEN TAUPŌ AND TŪRANGI**

- State highway 1 redirection, but I understand that it isn't council job.
- The 70 kilometre stretches between Taupō and Tūrangi should increase to 80 kilometres.
- Make the Taupō-Tūrangi highway 4x lanes.
- Please just fix the road between Tūrangi and Taupō. My car won't last much longer with all the potholes in the road. It's wrecking the suspension on my car!
- Alternative route for heavy haulage vehicles. Not use SH 1 between Tūrangi & Taupō. Truck accidents are regular.
- SH 1 between Tūrangi and Taupō should be of highest priority obviously to address the flooding along the Waiotaka straight, the bridge at Tauranga-Taupō and the notorious bends around Bulli point!
- The high traffic load on the State Highway and accidents that have occurred in the last 12 months have been critical to the impacts on both human safety and the wellness of our waterways and environment.
- SH 1 between Taupō and Tūrangi desperately needs addressing; Bulli Point area not fit for purpose and extremely dangerous.
- SH 1 to Tūrangi is very dangerous, esp. around Bulli Point. Trucks are often across the centre lines to get around. And potholes on SH 1 north of Taupō need urgent attention.
- Over-land route south.
- We need to see consistent pressure applied to central government about re-routing SH1 away from the lakes edge to more resilient route. Not only is Bulli Point an issue, but the Tauranga-Taupō bridge is too. The new speed restriction zones, certainly help a poor stretch of road, but having a expressway system that continues from the ETA to central plateau is a no brainer. Looking at options that are band aids on a problem needs to stop.



- Get that SH1 built over the top. It is embarrassing sending international guests from Taupō to Tūrangi to Taupō. The state of the road is dangerous and daunting to our internationals trying to drive the narrow roads on the other side to what they are used to. We ALWAYS recommend our guests drive this crazy embarrassing road during daylight. We should we be apologising for one roads?

### **INVESTIGATE OTHER WAYS TO GET ACROSS THE WAIKATO RIVER**

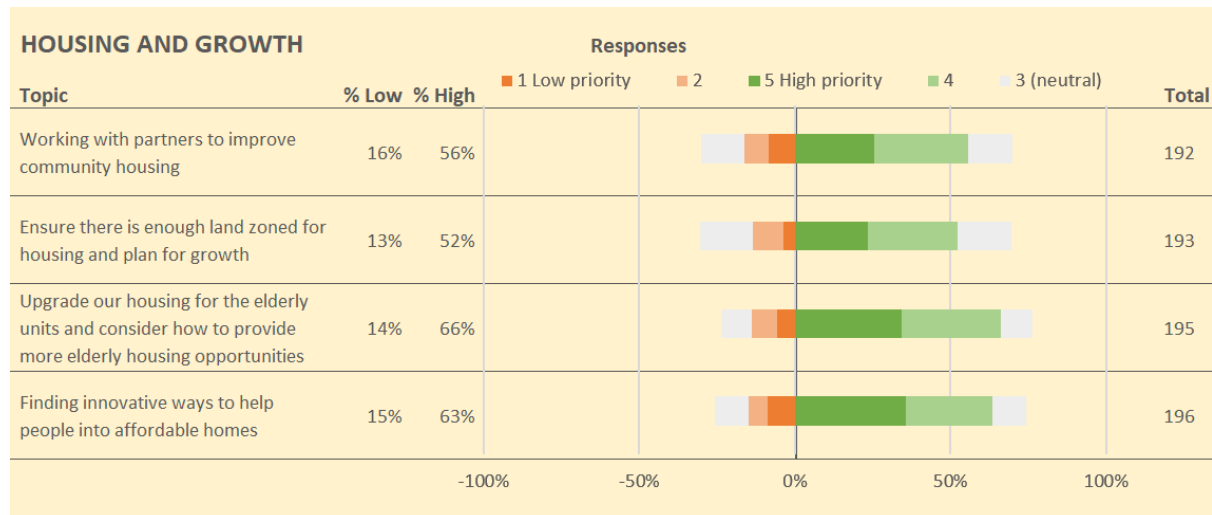
- If you built a bridge or flyover from the intersection of Norman Smith Street and the State Highway over to Waikato Street this would take a lot of pressure off the bridge into town and if it had a lane off from the north to Waikato Street, it could take traffic away from the roundabout at the Countdown and stop traffic building up to Tauhara Road. Or bring a bridge crossing in from Rangatira Park to take traffic coming and going from town. This could come out at Ricket Street or at Riverbank Road.
- I think we need to build another bridge across the Waikato River as the traffic lights at present are not doing a very good job.
- Any new river crossing needs to prioritise passive transport.
- I think it's a high priority to get a second bridge, especially if there is further development North of Taupō.

### **OTHER TRANSPORT COMMENTS**

- Less stop signs.
- Stop just decreasing speed limits they solve nothing and just cause more accidents. It's a waste of time and money for the ratepayer.
- I find that the new speed limits having made a difference to the speeds especially in Tūrangi.
- Electrification of all public transport including TDC vehicles - we must be the leaders in this transition and show our people the way.
- Encourage EV charge stations in Kinloch, Kuratau, Omori, Motuapa, Wairahanui, Wairakei etc.
- Support businesses to add electric car charging stations to businesses and public cars parks in Taupō.
- Removing trees and bushes that obstruct view on corners.
- Flights to other cities not just Auckland.
- These questions are worded in a way that I cannot give meaningful answers and you cannot get meaningful data from responses. For example, when you refer to safety at intersections are you referring to safety improvements for people on bikes or for vehicles. You state "Investing in the initiatives or improvements covered in this section would see us all pay a little more in rates." but some of these could require a lot more funding than others. What do you mean by "a little more"? Will all of us pay exactly the same amount of this little bit more? I don't want households that are already struggling to have to fund some of these things. What is Taupō DC's share of the cost of more frequent buses and what is Waikato RC's share?
- I would like to see fewer car journeys. Higher bus use and children encouraged to walk or cycle to school.
- I would like to see projects that reduce greenhouse gas emissions as the highest priority.
- Boating on the lake is increasingly popular and needs to be well managed to avoid accidents.
- More thought going into infrastructure before housing development.
- Review ALL projects and delete the ones that do not help the majority of ratepayers. Like E-Bike training!!
- All development and upgrades should be subject to a cost-benefit analysis and prioritisation ranking.



## HOUSING



### WORKING WITH PARTNERS TO IMPROVE COMMUNITY HOUSING

- Kainga Ora really are the organisation to do this work - we need to work with them and use their skills to identify where the need is and what we can do as a Council to work with them - might be re-zoning; might be better transport but we should be responsible for house building. That is not a council job in NZ.
- Housing for elderly and affordable homes is not the role of council, it is good to promote these but I don't advocate my rates being spend on coming up with innovative ideas when there is a ministry dedicated to providing for this.
- Housing should be central govt's job to provide, not council. Have pity on the long-suffering ratepayers!
- It is not council's main priority to be developing cheap housing for those who can't manage their own finances.

Why should all ratepayers subsidise those who spend more than they earn, get themselves into unmanageable debt or put themselves in situating of financial difficulty?

Council's record on providing housing is poor, with a previous development at low prices aimed at low income persons being on-sold at profits that ratepayers subsidised.

If you are going to do a development, maximise the profits for all ratepayers, for the benefit of all in the community, not a select few.

- Central government should be pressured to provide funding for any aged or community care provision.
- Social/affordable housing should be a central government issue not ratepayer funded (apart from council owned elderly units).
- I think community housing is important but it's also a responsibility of central Government.
- Housing is not council business. Zoning land for housing is council business. Council should NOT be in the housing business.
- Re: housing for elderly and affordable homes, this should be addressed by the private sector. If the private sector does not find it affordable, then local Govt. are unlikely to find better workable solutions and spend lots of money trying.
- People who want to live in Taupō need to work hard, save money and then buy a home. TDC should not be in the business of providing help for those who can not help themselves. Think of the ratepayers who are having to struggle with the crazy rate increases that are not helped when TDC looks at social housing. Tell the Government to pull their big fat finger and do more to help.



Council owned land can be sold to those that want to build a home. That is all TDC should be doing.

TDC needs to concentrate on the future infrastructure that is needed to support the new homes. That is the core business of TDC. NOT community housing or affordable homes. NO WAY JOE.

- It is not the job of council to be looking at affordable homes. Remove some of the barriers in regulations to build new houses and the Government through state agencies like Kaianga Ora / State houses should be looking at this question. Too expensive for council and drag on rates.
- Yes - work together as a 'Co-Governance' unit and utilise strengths and resources to make better housing decisions for elderly and struggling families.
- Council needs to refocus their housing options and crisis that is currently happening. Upgrading their systems and knowledge of papa kainga housing will be a start. There are some papa kainga developments currently underway in the TDC region but they are being help up by the council and their premature knowledge of papa kainga and finding solutions. This would help many Māori who are currently experiencing the impacts of housing and poverty in Aotearoa and our region.
- Concentrate on getting people out of emergency housing instead of putting them in NOT-fit-for-purpose motels and forgetting about them.
- Love what Iwi is doing down in Tūrangi with their community housing. I would love to see Mana Whenua in Taupō and Mangakino doing more with Taupō District Council like this.

#### **ENSURE THERE IS ENOUGH LAND ZONED FOR HOUSING AND PLAN FOR GROWTH**

- Better to increase height restrictions for new housing in brownfield areas than increase urban sprawl across greenfield areas.
- Rezoning Rangatira 8A16, Paenoa Te Akau, and Rangatira E to residential be prioritised.
- To include Rangatira E, Paenoa Te Akau, Rangatira 8A16 as residential growth areas.
- Reduce the ability to create high density developments in Tūrangi and other small towns. It does not fit with their character. This is not a metropolitan environment.
- Affordable and higher density housing and good growth planning is very important and needs to be balanced with good open space networks and parks - this can only be done by good council planning at the macro scale. Developers are too focussed on their areas of development, so needs to be done with a wider view by council.
- Before we build more houses and develop land for this we need to make sure that we have the infrastructure to support it. Also building more houses over the bridge ie Acacia Bay and Rangatira Park we need to have a second bridge for people to access Taupō town centre.
- Small local town centres need to be encouraged/required before any more subdivisions are approved (e.g in Nukuhau).
- Council can provide land and zoning but it is not the councils role to be helping people in to housing. Encourage greater density and building up around the cbd and maybe a couple of other key hubs. We do not just want to keep sprawling ever outwards. Start pushing the ministry of education for more schools in Taupō. Something out towards Wharewaka or Nukuhau/Acacia Bay would make sense and help ease some pressure and hopefully some traffic.
- New housing areas need to be designed with climate change mitigation strategies built including transport, Rainwater harvesting and other forward thinking solutions.
- River crossing needs to be sorted along with other infrastructure before more land is opened up
- Build higher rather than outwards.
- The Taupō population growth over the last 10 to 15 years has led to congestion around the town & environs and more housing without infrastructure will only make the issues worse. Instead of simply adding more houses we need something like a self-contained suburb. The Ngaroto area could do this if it had more than just a supermarket but that is a good start.

Affordable homes disappeared when the Govt allowed house prices to skyrocket by keeping interest rates so low for so long. Building affordable new homes does not work due to the out of



control cost of building so a viable alternative would be great but not multi-level cheap flats in existing residential areas which would take away some neighbours sun & turn their houses into unhealthy homes.

- Too many houses and empty holiday homes as it is. There is not enough industry or sufficient road network in Taupō for more housing. The roads can't cope with the traffic as it is, never mind building more houses.
- There's a housing shortage yet more growth in this respect adds to pressure on the infrastructure; less green space; pressure on the lake; a step away from what makes Taupō special.
- Maybe slow back on building new housing and rezone but help with old house in the district.
- We need more infill housing to reduce urban sprawl.
- Any housing growth plans need to ensure the environment is not damaged. We must not put too much pressure on our lake and native bush. We need to retain native bush and water quality needs to improve.
- The trouble with more housing and growth is that it puts more strain on our existing infrastructure, and more importantly how is it going to be funded, a rates rise would be unacceptable, not an easy one.
- With the expected future growth Taupō Hospital will need to be rebuilt at some point.

#### **UPGRADE OUR HOUSING FOR THE ELDERLY UNITS AND CONSIDER HOW TO PROVIDE MORE ELDERLY HOUSING OPPORTUNITIES**

- Maybe housing for the elderly should be for people who lived in the area, and a place that feels safe. Better lighting.
- Look to work with a wide range of providers including iwi/Māori landowners for elderly housing through facilitation, connecting landowner entities to funding options.

#### **FINDING INNOVATIVE WAYS TO HELP PEOPLE INTO AFFORDABLE HOMES**

- It is getting too hard to get into the housing market no matter what your age is. It would be great if there were some sort of Rent to own Schemes etc that would help people get that step onto the ladder of owning a home.
- Need more asap.
- More affordable houses should be built, we are very concerned about our future- how will we ever own our own home.
- How about affordable housing for people wanting to rent and work in Taupō. BAN AIR BnB!
- Affordable housing for low-income young families. STOP MORE AIR B&B's and Book a Batch they are taking up all our rentals put a cap on it.
- We want our families to stay living together but prices of housing in Mangakino is getting too expensive we need more affordable homes.
- Create a destination of quality homes not affordable homes, there is plenty of existing real estate that fits into the affordable category, new builds should be focused on quality.

#### **OTHER HOUSING COMMENTS**

- More support with mental health services/establishments.
- Be real with rates when it comes to size of house and age of homeowner. Don't falsify rates on inflated land value.
- Work with Central Government to change Rental Tenancy legislation to encourage more landlords back into rental housing market. Current legislation and changes driving landlords into Air BnB - reducing rental stock.





- The council should lobby the central government to make changes to legislation to attract private development for rental properties.
- Again, these questions will only give potentially misleading feedback. More context is needed. What partners are you referring to in Q9?
- Stop cutting down all the large trees! 😞
- Better notification to people who will be impacted by Kaingaro Ora developments, e.g., Rangiomohia Road residents. There needs to be more transparency around who is going to be housed, consideration taken into where people will park as most households have more than one car - despite our current govt thinking we will all walk, ride our bikes or take the non-existent buses.
- [ ] waste of time and space, fix outside of Taupō [ ].
- Discourage non-recyclable plastic wrap, polystyrene and plastic landfill problems in building consents. Encourage rainwater harvesting, greywater reticulation and solar energy investment.
- More law enforcement after daylight hours.
- I feel like the housing build is focusing on high-end byers, Wharewaka subdivision is a great example of big housing that is mostly empty...
- More smaller homes would suit elderly and single people. It seems new homes all need to be 3 bedrooms and 2 bathrooms.
- Resolve the issue of many houses in Taupō being unoccupied for 3/4 of the year and yet there is a high demand for more new houses and affordable rentals.
- Tiny house community housing.
- Stop people buying holiday home & turning them in air B&Bs take a leaf out of Europe who for example have banned people who are not connected to the place to buy a house unless they are connected to the area via work, family ect. in addition Europe has also moved that people can only own one house and if they chose to have a proper holiday home they must pay extremely high property, rates and land taxes.
- What is the ratio of rental / lived in homes: Air bnb and accommodation?  
I think there are too many houses being built as air bnb / bach style homes and not enough for permanent residents. I don't think extending onto our whenua is the answer either.
- There are not enough houses for 1 and 2-person families - single-parent families and retired people. Why not consider 'pocket' subdivisions similar to what is being done in Ngongotaha?
- I've come across a few initiatives that help building smaller, more affordable houses for smaller families. They team up with people to invest in the property and the people get the house in the end. Could the council afford to be the funding source? Or could the council partner with the charities interested in this space?

I've been in the space of ground source heating. A geothermal option using heat from the ground. It's a great technology, widely used, and hopefully one day also popular in Taupō. However, this resource also needs to be managed from different perspectives and it would be great that the council starts opening the space to regulate and promote this as an alternative energy source. It is especially good for public owned buildings or as the systems can take away the pressure of the elderly or low-income family's pocket while they're in the social housing. I hear some people who can't afford the bills and therefore live cold, with the obvious consequences on the public system for health and wellbeing.

I find it very upsetting that the rules to build seem inconsistent. The land coverage, for example, some subdivisions seem to have a preferable rate over others. I'm not sure how it works, but I hope rules are applied to everyone consistently.

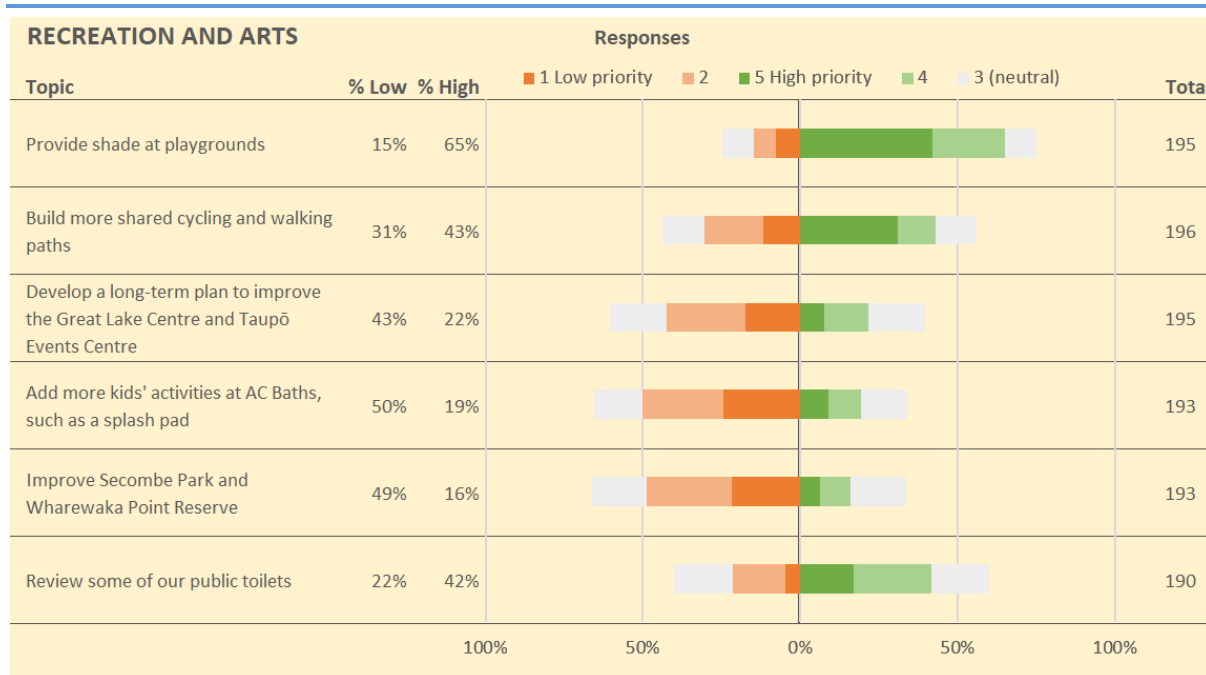
We're not sure about the land developed on the eastern side of Acacia Bay Road. In the last year, there are 18 new access roads, and it looks like building will be on the way. Is there any provision for infrastructure with this new development added to the others in Nukuhau and Mapara Road? And I mean from roads to recycling bins, which I have pointed out in the past too.





Thanks for giving time to the housing needs of the families in our town. There are still people struggling for a place to live (singles, small families, workers, broken families) and having a home to rent or buy shouldn't be a fortune, we all could do a little to contribute towards the privilege of people having a home.

## RECREATION AND ARTS



### PROVIDE SHADE AT PLAYGROUNDS

- some of the shade at parks should be large specimen trees.
- Shade at playgrounds? Whose stupid idea is that?

### BUILD MORE SHARED CYCLING AND WALKING PATHS

- Work with iwi and hapu to create a round the lake cycle trail.
- The new cycle ways and paths around Taupō have been awesome. Would be great to see more pop up or improved (such as pathing the entire shorefront to Waitahanui). Understand cycle ways aren't a priority for most but good to see how busy they have been recently).
- As before, Tūrangi needs more cycle, walking tracks. Out to Tokaanu wharf and possibly to Stump bay as this is the only safe swimming beach at Tūrangi end of lake. River track is only good for intermediate cyclists.
- Plan for walkways and walking access between subdivisions, including lifestyle areas such as Mapara Rd - Acacia Bay. Please no more gated communities unless they allow locals walking access.
- COMPLETE the Round the Lake Cycleway- as in COMPLETE, not partially and pat your backs on well done section, FULL 360degrees, the whole circumnavigation thing. Then celebrate!
- The cycle ways around town have been significantly underutilised. Council and Bike Taupō have been asked for data on cycle numbers but both have nothing to report. The cycle lanes on Tongariro St and up control gates hill are a waste of space and could be better used for vehicles. The bus stop is in dangerous situation (for passengers and bus drivers) with a cycle lane and vehicles immediately next to where they park. (The bus stop needs to be repositioned).
- Shared cycling and walking paths have a huge benefit for the local community but also visitors to the district. If we can make these the best they can be along with family friendly activities at AC Baths a priority we will keep thriving as a great destination and community.



- This only addresses Taupō township, there are many outlying areas that contribute substantial rates and they should be getting higher priority for walkways, cycleways and playgrounds.
- Cyclist and pedestrian paths should have some degree of separation. As a pedestrian I feel unsafe on waterfront walkways.
- The trouble with having more recreational areas whether cycleways, walkways etc, is that they all have to be maintained, so who is going to pay? I'm all for it as long as it's not me the ratepayer.

### **DEVELOP A LONG-TERM PLAN TO IMPROVE THE GREAT LAKE CENTRE AND TAUPŌ EVENTS CENTRE**

- Additional court space needs to be built otherwise we will lose clubs/groups to private organisations that are considering building purposeful venues.
- Access to more courts required.
- Roller skating (not roller derby) time slot.
- Wow... you mention Art's yet no mention of the Taupō Museum and ART GALLERY! In these difficult times the Museum and Gallery probably don't need a lot of money spent on them but acknowledging it as a wonderful ARTS facility doesn't cost anything. Also not mentioned is the ARTS STRATEGY! How much money is being wasted on consultation when you could have just reinstated a community ARTS worker roll.
- Art Gallery and Museum needs revitalisation. Given the rich history in this part of NZ the museum part is rather underwhelming. The art gallery is pretty basic too.
- More opportunities for artists to showcase/liven up Taupō/Tūrangi.
- Need to revisit the development of an Arts, Culture and Conference precinct in the Domain - significant refurbishment of GLC required to attract growing conference and incentive markets.
- GLC needs more seating.
- Museum needs attention, more community arts places.
- Taupō is becoming a back water for significant cultural events - the Great Lake Centre needs to be renovated and enlarged so that we can again play host to the Symphony Orchestra & larger ballet companies.

### **ADD MORE KIDS' ACTIVITIES AT AC BATHS, SUCH AS A SPLASH PAD**

- I would love to see a toddler friendly pool at AC baths.

### **IMPROVE SECOMBE PARK AND WHAREWAKA POINT RESERVE**

### **REVIEW SOME OF OUR PUBLIC TOILETS**

- Toilets 1 Whakamaru maybe 3 flushing Toilets.
- Taupō to Tūrangi remove the 3 long drops near the water edge.
- Up grade /rebuild most of the Toilets in the Tūrangi area.
- Why on earth did you close public toilet during the lockdowns? What were people supported to do??
- an assessment of the spatial spread of public toilets is a great idea particularly in new areas of Taupō.
- More public toilets or long drops between Taupō & Tūrangi. Upgrading of highly used toilets eg. Kaimanwa reserve. Shaded playground and picnic areas in highly used public reserves. Additional child activities at Turtle pools?



## PLAYGROUNDS

- We need seating at parks/playgrounds so grandparents/whanau can sit down to watch their children.
- We need much better playgrounds for children in all our suburbs. Most of the children's playgrounds in Taupō are very sad and tired. Children and their care givers (parents/grandparents/ etc.) benefit from having playgrounds to be active outdoors. For low-income households this is particularly important as so many indoor activities as well as other outdoor activities cost money.
- You have NOT addressed any playgrounds that are not in Taupō. Remember that there are areas outside Taupō that pay HUGER rates and deserve equal priority.

## ACTIVITIES FOR OLDER KIDS

- Outdoor basketball court next to Youth town Taupō.
- More youth programmes and trips i.e., up Mountains, organised walks.
- Free access to pool for locals- maybe 1 day a week.
- Cultural performing art events.
- More cultural activities to celebrate diversity.
- Free golf afternoon.
- Free e scooter.
- Skate Park.
- Indoor activities that are affordable.
- More fun things to do for kids that doesn't cost a fortune.

## OTHER COMMENTS RECREATION AND RESERVES

- Close access to parks & reserves by cars after dark to curb misuse and damage to grass surfaces which is very evident.
- More for young people, update the skate park look into permanent ice rink?
- Increased planting of some of the public parks and reserves. This provides shade, biodiversity and an aesthetic improvement. There are some large grass areas that are underutilized. Allow other developments like 2 Mile Bay Sailing Club. While they are private businesses they provide community hubs, draw in tourists, use the lake and are recreational area.
- Taupō region has become known for cycling, support the Bike Taupō and Greening Taupō initiatives. Lake front reserves is disgustingly full of blackberry, gorse and plastic weed matting breaking up. It is embarrassing that TDC does so little on our popular trails, gully walks, access trails...why should volunteers be planting natives and weeding.
- More facilities like basketball hoops for informal groups to gather together and be active.
- Consult with DOC and local community groups to understand how the TDC can assist communities to develop their own recreational resources; particularly sporting clubs.
- More BBQ facilities at parks or reserves next to the lake.
- Money money and more money. Every time I have raised the repairs of reserves, since 2011 Councillors say "we have no money". It seems ratepayers can say many things but Councillors find all the excuses to find a reason not to take any notice. TDC just do what they want, based on the staff recommendations, regardless of what the public suggest. Council works a bit like a poor system of smoke and mirrors. Maybe when 'the moon turns to cheese' some of the above may get the nod?
- Council priority is roads, drains and fresh safe drinking water. Should never have dismantled the previous council building on the lake front. A recladding would have been better.

### REVIEW KERBSIDE WASTE COLLECTION SO IT'S SAFER AND BETTER FOR THE ENVIRONMENT

- Curb side Recycling in Taupō is pretty woeful. I don't have a lot of confidence that recycling is occurring as it should. The guy who is in charge in Taupō has been sitting on his hands for years, where is the innovation?
- Support the use of bins for kerbside waste collection. More important than food scrap collection is garden waste collection. Council should continue to encourage people to compost food scraps at home rather than introduce collection, it doesn't take up much space to compost at home. We need garden waste collection - too many people are dumping their garden waste into the gullies. We need to keep our gullies weed free and revegetate with native plants to provide water filtering ecological corridors. Council can do more to help with native birdlife in Taupō by doing this simple thing. We want our future generations to enjoy the benefits of our indigenous wildlife. We need to find an alternative location for the landfill. It is an absolute disgrace that we dump our rubbish at the foot of Mount Tauhara, this needs to change.
- Rural areas - Make sure recycling is actually recycled properly as people are losing interest when it's not. Also pick up recycling from rural areas.
- Replace yellow refuse bags with wax paper or similar.
- Rubbish collection should be available for all residential and commercial properties, on a fair and equitable basis. The existing policies are not fair or equitable for some commercial properties where there is NO weekly collection. A total review of rubbish collection must be completed.
- More bins- wheelie bins for home and around town especially around the lake.
- Bins not bags- less plastic.
- Bins, bins and more bins.



### **ADD A KERBSIDE FOOD SCRAPS COLLECTION**

- Once again you are looking at this from a Taupō town perspective. Where would these supposed food scraps go? At the moment our recycling just gets thrown in the truck altogether even though it is sorted by residents. I believe that it goes to Taupō to be sorted.?
- Taupō - Recycling collection for Tukairangi road.
- No to kerbside scraps, just attract dogs and cats and rats.
- I already compost food scraps. Don't need a food waste bin.
- I like the idea of food scrap collection, but I have compost and worm bin so wouldn't use it.
- Strongly in favour of food scraps and green waste collection and the use of wheelie bins.
- Encourage people to compost their own food scraps, it is so simple and halved our collected household waste.
- Food and compost collections.

### **MORE OPPORTUNITIES TO RECYCLE, REUSE WASTE AND REDUCE GREENHOUSE GAS EMISSIONS**

- There should be a greater focus on reducing general waste going to landfill, e.g. incentivising waste reduction by increasing the cost of the user-pays waste collection system.
- Waste should be managed at source - companies need to start taking responsibility for the waste they generate. At supermarkets, we should be rejecting waste imposed on us, but unwrapping before we leave. Why is there plastic around cucumbers? Why do tomatoes come in plastic containers? Why is everything packaged so that we have to buy what the company wants us to buy? Why can't we return all bottles to the supermarket? Every bottle sold should be returnable. If TDC council lead the way in this, NZ would follow. It just takes one brave council to say, Enough! Time to hit the companies who create this nightmare and then we will start to see an improvement.
- We desperately need soft plastic recycling to reduce the waste to the landfill. The council also needs to support schools to develop their own gardens and ground to use their own wastes as compost and divert school wastes.
- I think the council could encourage individuals to be personally responsible for caring for their local environment i.e. doing their own composting and reducing their own waste rather than council "doing it all" by introducing more expensive and plastic using big bins etc. Council could introduce rules where businesses who sell packaged items have to supply bins in store for people to leave the packages in the stores- this could hopefully lead on to manufacturers reducing the amount of rubbish packaging being produced- which would be better for the environment, and cheaper for the council and therefore the ratepayers.
- I would like to see an increase in fees for the Pay as you throw. We should not be encouraging or subsidising the population to produce more waste. This is ethically and morally wrong and destroys our planet.

### **REDUCE GREENHOUSE GAS EMISSIONS FROM COUNCIL'S FUEL AND ELECTRICITY USE**

- Everything we do must be with climate change front and centre front.
- TDC needs to develop and activate a plan to be Carbon zero by 2050.
- Transport is an environmental issue. The impact of all transport expenditure on greenhouse gas emissions should be assessed.
- Sustainability should be on the forefront of Taupō city council. As we transition into a climate that is warmer, more unpredictable with extreme weather events we need to be pro-active. This means putting action now to mitigate the effects of climate change (not building houses close to flood zones/ rising lake levels), encouraging the use of EVs and building more charging stations, increasing cycle lanes and monitoring our greenhouse gas emissions.



- We really need to change our infrastructure so that it supports low-emission transportation. Also we could definitely improve our landfill and rubbish system too.
- Every effort should be made to reduce emissions and mitigate against the effects of climate change. It's daft to talk about reducing Council emissions from fuel & energy then bring Supercars to Taupō.
- Less council vehicles.
- Reducing waste will reduce landfill, 70% is compostable or support MYNOKE. Why doesn't TDC use EV cars!
- Make intersections better flowing to reduce the fuel use of vehicles from stopping and starting unnecessarily.
- Emissions are NOT dangerous, nor are they a risk to humans. TDC must not waste any of the ratepayers' rates on the management of emissions, unless it is mandatory by law of the Government. There is no need or want to 'capture or reduce' landfill emissions. It will achieve no benefit or real outcome that will ever benefit the TDC ratepayers. Just the woke greenie activist minority in the Taupō District. Just run a survey or poll to find out what the ratepayers understand about our climate and the science of greenhouse gas emissions. Council does not have a mandate to manage emissions. It was not an issue that was debated at the October election in 2022 and there is every chance that the next Government will be reviewing the Zero Carbon Act and ETS laws. TDC must NOT approve any projects or costs that are not specifically imposed by the Laws of NZ.
- All these matter require investments, but once they are in place, they have the potential to save lives and resources in management, restoration, remediation. Items like scraps collection or food waste could be tackled together with community groups, schools, etc. TDC's waste can start being addressed by having a saving culture. Have you driven past your offices at night? The lights are often on. Flood lands and water management is important for infrastructure, but also for long term water availability and management of fire risks which will be problems eventually. So thanks for taking charge here, invite the community, we're here to help.

### **CAPTURE AND REDUCE LANDFILL EMISSIONS**

- Reduce the cost of tip fees so people won't be doing fly tipping. Do not introduce unnecessary costs that would impact our rates, such as introducing monstrous wheelie bins and food scrap bins when these are not required nor wanted.
- Re waste: I only buy products that have recyclable packaging. I haven't thrown out any waste in months and my waste bin (hardly ever used) is the size of half a cereal box. I'd suggest that the landfill could be retired altogether if we all got on board with recycling (including ratepayers, manufacturers and councils). Re food scraps - what would council do with these?
- Capture the gas from the land fill for productive use.

### **KEEPING NEW BUILDINGS OUT OF HIGH-RISK FLOOD AREAS**

- Re new buildings in flood areas - If an area is prone to flooding, surely the district plan would detail that and insurance companies will therefore be aware of that and charge premiums that are applicable. Councils role should be to zone the land, not be peoples nannies.
- Question 26, surely if we build new buildings, we make sure they won't be flooded yearly? Anything else would be irresponsible...
- The water quality of Taupō moana needs to be a top priority for Taupō DC, and as much a district council responsibility as a regional council responsibility.
- Gully planting = more slash/trees that wash down in big rain events. There is very few areas that are under risk of "FLOOD" events, in the traditional sense of the word. However, Tuwharetoa traditionally kept their housing well away from the lake due to Lake Tsunami. So in that theory, we need to move the whole town of Taupō: 1926 ½ meter of water washed up Tongariro Street and damaged structures, plus damaged the Horahora Power Station, buildings in Meremere, Mercer and Port Waikato. This was a Lake Tsunami.





- The high water table and flood areas need to be addressed. This needs to happen by taking responsibility for the impacts that the waterways, rivers and creeks have on the surrounding lands after years of misuse by the Crown. EG: Waioatoka River. Come up with a plan and follow through. Don't pass the buck to other councils or individual whanau.
- Preventing flooding and erosion because of climate change, and planning for civil defense emergencies.
- This should be top priority for council. For our kids!!
- Electric is no good in the rain and under power for some jobs.

## **A PLAN TO MANAGE FORESHORE EROSION OF OUR LAKEFRONT RESERVES FOR THE LONG-TERM**

### **GULLY RESTORATION AND RESERVE PLANTING**

- Keep planting exclusively natives.
- Monitoring District Plan vegetation clearance rules and prosecuting landowners undertaking clearance of significant natural areas.
- Ecological corridors around the lake.
- If I could rate it higher for gully restoration and reserve planting I would.
- Retain all native vegetation that exists in our region today.
- The foreshore planting is excellent and should proceed.
- A strong focus on climate change, carbon zero and adaptation, including nature-based solutions. How is Council responding to climate change? How will Council achieve carbon zero? How can Taupō lead the way in its response to climate change?

Low carbon events. Bringing super cars to Taupō, while a benefit for the local economy, just isn't the sort of event this town should support given climate change. Taupō should lead the way as the low carbon outdoor events capital of NZ. A round of the e-car circuit would be an alternative to pitch for.

### **DETERMINE THE LONG-TERM FUTURE OF BROADLANDS ROAD LANDFILL**

- No alternative to Broadlands Landfill is given, so very hard to make an informed response.
- You haven't told us the life span of the current Broadlands landfill or given any options that may be available.

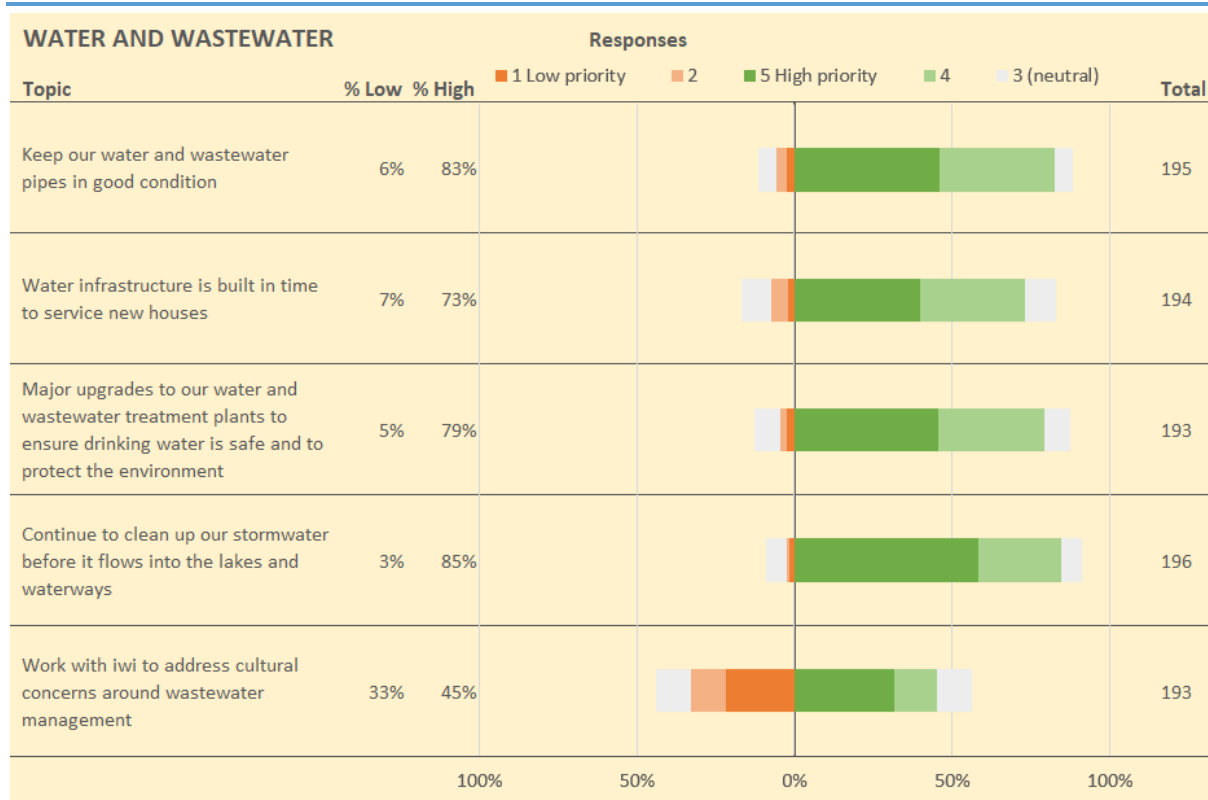
### **OTHER ENVIRONMENT COMMENTS**

- More pest control, making traps and learning about pest control work.
- More geothermal projects.
- The current practice of referring complaints relating to overgrown vegetation is useless. NZ Fire Service limit their instruction to mitigate only when they identify an obvious potential source of ignition. ????? Has no one heard of WILD fires. I have years of official stats on random sources of fires. We need to be ahead of the game and practice risk reduction, especially in residential areas.
- I am very concerned about the beggars around town. This is a business and they have set up outside my building and nice people who do not know them, are giving them food and money. They are not homeless and someone needs to investigate the fact that they are encouraging other people to group around them. My business is being affected by this and I cannot cope with this anymore.
- Stop cutting down our big trees! 😞



- Ban 'Roundup'... it's sterilizing our soil and killing the bees.
- Make the trust invest in improving lake front, Taupō is very unlikely to flood [] as the ground make up is great for drainage.
- Taupō has massive energy generation with steam these companies need to be major supporters of improving the local environment as they are harnessing the environment for their business.
- Target blackberry, gorse and broom urgently on all tracts of land. Especially council/NZTA managed land.
- Monitoring ground water quality to ensure the lake remains pristine.

## WATER AND WASTEWATER



### KEEP OUR WATER AND WASTEWATER PIPES IN GOOD CONDITION

- Wafer is a huge expense. I feel council has done a pretty good job. But it's a liability not an asset. Give it to the govt.
- Main issue is financial. Lobby to be able to better fund major, critical, and long-term infrastructure. Start with the concept that nobody owns water.
- Council should endorse the Affordable Waters Reform programme and pass on responsibilities for maintaining these services to a larger entity with greater financial capabilities.
- We need to work with the best water engineers we can find - that's who we should work with. This is why councils exist - to manage these issues for their people.
- More frequent gutter sweeping to keep gutters and drains free from debris, to reduce risk of localized flooding.
- All deciduous trees should be removed from homeowners boundaries where leaves end up in storm water drains.

### WATER INFRASTRUCTURE IS BUILT IN TIME TO SERVICE NEW HOUSES

- New subdivisions should be put on hold until all infrastructure is in place, eg all what we have been replying to.



- To prioritize the upgrading of the wastewater capacity pipes project to include Rangatira 8A16 - 61 Huka Falls road.
- "32.Ensure our water infrastructure is built in time to service new houses" what a dumb question. This is a requirement under the RMA that developers contribute to upgrades. Make sure drinking water, now with the Town Mains upgrade almost complete and in PTE Pipe, reduce chlorine from 28ppm down to WHO guidelines of no more than 4ppm.
- Surely council only approves new development to the point our system can manage?

### **MAJOR UPGRADES TO OUR WATER AND WASTEWATER TREATMENT PLANTS TO ENSURE DRINKING WATER IS SAFE AND TO PROTECT THE ENVIRONMENT**

- I don't think the Tūrangi wastewater treatment plant should be replaced but it should be upgraded.
- Tūrangi already has a good water supply.

### **CONTINUE TO CLEAN UP OUR STORMWATER BEFORE IT FLOWS INTO THE LAKES AND WATERWAYS**

- We need to adopt the best stormwater treatment practices - our lake and environment is too precious, a very large part of our local economy and what brings people to our district to visit and live relies on the health and wellbeing of our lake and wider environment. It is an environmental crime that water goes untreated from the grate to the lake.
- Water filters to prevent lake contamination.

### **WORKING WITH IWI TO ADDRESS CULTURAL CONCERNS AROUND WASTEWATER MANAGEMENT**

- Important to honour the mana whakahono agreement.
- Support projects and advocacy that strengthen opportunities for iwi and hapū to work in partnership with council.
- I was careful in my consideration in answering these issues given the very contentious issues surrounding Three Waters. Water is vitally important, but I don't buy into the ideology of 'iwi or cultural' input being necessary. Water is water for all. It doesn't need to be a cultural 'problem'.
- Under Te Tiriti o Waitangi, Council MUST work with iwi in regards to ANYTHING to do with the land and water.
- Depends largely on the 3 waters / next election results. Councils record of wastewater spillage has been poor but recent upgrades may have addressed this. Consultation with Māori is apartheid and should be dismissed for the nonsense it is. We live in a democratic society and the contribution that the colonials made have to often been overlooked and marginalised. Why should Māori be 'experts' if consultants for infrastructure? Ask relevant engineers or other professionals, not someone just because of their race.
- I would imagine that upgrading and maintaining our infrastructure would overlap a lot with many of the iwi's goals and concerns.
- Build more co-management relationships with tangata whenua – Tutemohuta Reserve and Waipahihi C75 are examples of this type of collaboration.
- Appropriately resource the co-design, implementation, and servicing of formal relationship agreements between hapū and council.
- Incorporate clear evidence processes which demonstrate how the participation process is endorsed by hapū and Māori landowners alongside iwi.
- Iwi does not matter.
- Do not get involved with co, governance.



- There needs to be specific mechanisms that address the needs of Māori landowners of collectively owned land to participate in council processes e.g., specific Māori land development advisor.
- Align council processes with iwi forums for engagement.
- Support for Enabling iwi/hapū narrative to be shared as determined appropriate by mana whenua, increasing our knowledge, understanding and engagement with Iwi/Hapū to showcase their narrative as they deem appropriate.
- Iwi are NOT a privileged group and working with them should be part of working with the general community - not some 'special' thing!
- No co-governance....No co-governance....No co-governance....No co-governance....No co-governance....
- Yes work with iwi, this is their taonga, and it is imperative to have them add the table to address cultural concerns.
- Our drinking water is very good in 2023 and there should be no need for any 'major upgrades!' Wastewater management has been successful up until now so why all of a sudden does an iwi need to get involved? It must be assumed that the health and safety issues are in accordance with Government guidelines, set by health officials who know what they are doing. That is not to say iwi know better but I see now need to have an alternative party consult on a subject that is working well. KISS. If it is not broken, then do not try and fix it. Just money down the wastewater drain!!? Councillors can surely see the sense of that?

#### **OTHER WATER AND WASTEWATER COMMENTS**

- What do you mean by "significant" above in Q31? What do you mean by "major" in Q33? Council should provide a lot more public education and other measures to deter residents from using potable water for watering lawns and to promote water resilient gardens.
- Yes Do applications under RMA require investigation of surface water runoff for high density development. No one listened to re this matter with a KO development here in Tūrangi.
- Wastewater and stormwater infrastructure have been critical during the Auckland floods and extremely lacking.
- What about Tūrangi?
- All of the questions in this survey relate to "paying a little more in rates" which I find unacceptable. The council need to find smarter ways to do all these projects without costing the ratepayer.
- Invest in upgrading the village around Taupō that pays for it (from Wairakei).
- Do we all resident pay for water management proportional to our consumption? Are we aware of the limitation of our clean water? I see lots of irrigation on pavement, for example. Do we pay water per person, per m3, per m2? I have the feeling our payments are not proportional to our consumption.
- Clear the oak leaves of Lake Tce in autumn and winter would help.
- Encourage rainwater harvesting & greywater reticulation.
- Ensure freshwater resources are used sustainably.
- Improve the sun surface irrigation of grey water at Kinloch so there are no leaks and boggy areas.



## TAUPŌ

### WALKING AND CYCLING

- More spaces for bike parking in Taupō town will be appreciated. Maybe a lock hiring service from the I-site could add value.
- Safe crossing areas across Spa Road for pedestrians.
- Continue upgrades and extensions to the lakefront walkway.
- Continue the foot/bike path along the eta to red bridge to join in with the trails along the river there.
- Rotorua to Taupō cycle way.
- Rotorua to Taupō cycle way.
- Complete cycle access to Waitahanui & Wairakei as 90% finished now.
- The Taupō Council has been doing an above average job I believe, although I am not a fan of the bike track beside State Highway 1, as the cost of the concrete and the 'emissions' saved vs the concrete emissions, I believe will never be cost effective. Other cycle track/shared path around the lake is excellent and should be continued all the way to Tūrangi, were that possible.
- In Mapara Road/Acacia Bay, a walking/cycling connection strategy could assist to provide future thinking around future connections and future investment in paths. There are under-utilised reserves/gullies which could be developed in this manner, this would also direct future developments connections.
- Under or over passes along lake terrace for pedestrians and cyclists.
- Much more safety for people on bikes - Taupō DC needs to encourage much more uptake of active transport especially with the ease of travel afforded by e-bikes, and to reduce use of vehicles for short trips. A 3m wide sealed shared path (similar standard to that on the ETA) should extend all the way to Waitahanui.

### INTERSECTIONS

- Bottlenecks at Spa road roundabout - and Titiraupenga lights - new layout does not seem to have helped this greatly. Solution for major events and large numbers of visitors coming to town e.g Supercars and Ironman Worlds.
- Could we explore a roundabout at Tauhara Rd/Taharepa Rd/AC Baths Ave? Very busy at times and people driving very fast through there.
- Roundabout at Tauhara Rd/Taharepa Rd/AC Bath Rd intersection please! Busy and fast intersection.
- The stop signs on the intersection by Chemist Warehouse should in my view be a roundabout.

### BUSES

- It would be great if the bus could continue out to Acacia Bay.
- If emphasis is going to be put into increased public transport, consider prioritising East Taupō/ Wharewaka/Ngaroto axis as the areas has an increasing population with reasonable distance from the town centre.
- Buses to the airport? Taxis are overpriced and not always available.
- Special event buses to help with activities at Owen Delaney Park & Taupō Motorsport Park - Not all visitors have vehicles.
- Transport from town centre to activities like Huka falls, Honey Hive and other regional activities - Not all visitors have vehicles.



- A tram or bus lane with more regular buses along Lake Terrace from the CBD out to the airport with stops along the way. This could become a tourist attraction as well.
- Re, buses frequency. Would it be possible to consider buses with smaller capacity in the mix? Don't know if they will be as expensive as the big ones.  
Thanks for making it possible to pay again with cash at the bus.  
A public route to AC baths might be a good idea.  
Additional paid parking space might help people to opt for buses rather than driving.  
Maybe a few more often routes from Rangatira Park, and Acacia Bay/Nukuhau could encourage people to take the bus. But, how to give the bus a priority lane to go faster than the traffic on peak hours?
- Taupō connector 38 could have a stop at the medical centre/gp at Heuheu street.
- Better bus scheduling i.e to run later in the day.

## PARKING

- A multi story car park in one of the current parking lots to increase capacity in town.
- More car parks at Paetiki Shopping Centre.

## RESERVES

- Me and a lot of other people have been waiting for the playground at Wharewaka Point Reserve to get an upgrade because a lot of people use this playground.
- You should have more things for people to do at Wharewaka Point Reserve.

## TAUPŌ TOWN CENTRE TRANSFORMATION

- Tongariro St is completely idiotic. The herringbone parking configuration is dangerous and impedes traffic flow all day but especially at peak traffic times. A ludicrous situation.
- Close off the Taupō town lake front to all traffic and make a pedestrian area only.
- You need to fix the hash that you have made of town centre with all the traffic congestion that it has created. The main street with angle parking on each side is such a mess. It only takes one longer vehicle to park there and no one can get through. It makes it narrow and dangerous and one side should be remove.
- Cars going in front of the Roberts street should be stopped. Access for drive through could be rerouted to the alley behind the KFC. The speed cars travel through there is not good and people park everywhere anyway. The whole effect of upgrading that street has been ruined by allowing cars through.
- The bus stop for intercity buses needs to be moved off the main road as it's dangerous the way they park and are unable to reach the drivers side lockers without blocking the road. Where the old St John building was would make a good bus stop permanently.
- Review the prioritization of the traffic light sequencing at the Spa Road/Titiraupenga junction. Review positioning of parking bays in centre of Tongariro St.
- Stop installing (in fact remove) traffic lights.  
That are internationally proven to (compared to roundabouts) - be more costly to install, are more dangerous (by a factor of up to 4), have around 30% slower flow, are visually more invasive, are less accepted by drivers, cause more congestion.

The bypass around the Taupō cbd was frankly a stupid idea, that increases time travelled, decreases the flow into the cbd (which is TDC's Objective 2.3.2 to promote the cbd financially, culturally etc), and has notably increased congestion.

You have removed the traffic lights at Tuwharetoa and Te Huehue but refused to explain why, while vastly improving the flow at this intersection. Then installed other traffic lights (Titiraupenga) that had the opposite effect (see above), again with no explanation.





No doubt this is the influence of the previous CEO, [], who was more interested in huge budgets and control, than efficiency, common sense and democracy. He has thankfully gone, so the opportunity now is to do what the vast majority of people in Taupō want - roundabouts, not traffic lights.

- Close the through traffic lane in Roberts Street, outside the restaurants.
- Reinstate old road through water front to help with people travelling through wanting to get to northern suburbs.
- I don't agree with the way council has laid out the road on Tongariro street with regards to parking, that herring bone approach is very dangerous especially for pedestrians. It all very good and well pedestrian zones, however it looks like very little attention was paid to vehicle traffic and parking.
- Completely remove traffic from the new water front development. It had so much potential but is somewhat ruined by the amount of cars and parking along it.
- Aim to remove Traffic lights and replace with round abouts. Redesign some of the new road layout in Taupō.... not traffic or pedestrian friendly.
- The traffic lights are a bad Idea. Environmentally, frustratingly and pure traffic flow and safety could be infinitely improved by using roundabouts. 30 Kph around schools without times when active is really silly idea. During other times of the day and night other than beginning, lunch and after school there are no children around these areas. No one will follow the rules if they are not sensible. The stop sign in the middle of Tamamutu St causes some major backups and very few people actually come to a stop there. Also the stop sign just causes more pollution at this position. Another example of a change badly thought out.
- The new Taupō town layout really isn't working too. I get that it's likely designed to accommodate for a new Waikato River bridge but almost all the Titiraupenga Street should have round abouts on them like Ruapehu Street does (have it on good authority that the person in charge of roading around here went to the ends of the earth to avoid roundabouts... and I think that's to the disadvantage of the community). The intersection outside Chemist Warehouse is horrific to say the least.
- The lake front fencing blocks the lake view and then shrubs have been planted behind which once established will block out the view completely- please consider removing them.

### **KERB SIDE COLLECTION**

- Hawaii street no rooms for bins- 4 house on Hawaii street (8,10,12 2/12) would like small recycling bags please.
- Don't like the bins, don't want them – I bag per month or 2.
- We do not want large wheelie bins; we want to choose a smaller bin.
- Elderly people will struggle getting their bins out especially mobility scooter users and people with poor mobility.

### **TRANSPORT**

- Suggest a panel of local engineers review draft traffic plans- peer review.
- Reconsider 30km speed limit to 40kms outside Paetiki shops.
- Need a 2<sup>nd</sup> bridge please.
- The 50 km speed limit on lake Terrace at Wharewaka should be put back to 80 km Or 70 km/hr.
- Put the speed limit passed Wharewaka back to 80 or even 70 there are no personal driveways connected to that road so no need to make cars crawl through at 50.



- Introduce an air braking restriction on the ETA at the Taupō airport roundabout particularly after 10:00 pm until 6:30am. The noise from trucks braking at this roundabout is disturbing residents in the Nga Roto subdivision.

- Have lane swimming till 9pm- just indoor so not as many lifeguards required i.e., close the outdoor and leisure pools and promote for lane swimming only from 7pm-9pm.
- Lack of lifeguards and swim teachers is having a detrimental effect on TDC providing a good level of service.
- Bring back the group sessions i.e. Power fit, Zumba and spin classes – they were always well attended and fun.

- More dog control.
- Please don't forget the Arts and the amazing doc the Nicola has done.
- Pull back on big new ideas until our countries financial situation improves. Spend money on keeping our existing facilities and community spaces looking clean and tidy. Our town looks run down and filthy. The gardens are messy, there are weeds as tall as bushes growing out of gutters outside the library and Great Lakes Centre! Taupō used to look wonderful now it looks shabby and is an embarrassment. No the Atea area doesn't make up for it.
- More schools.
- Yes as council owns the berms then they should be inspected to see if any plantings or rocks have been planted on to berms, would be great if some could be turned into parking, especially the shorter roads that have businesses in them, e.g, our st Fletcher has three businesses plus a retirement village, most berms have rocks and some have trees and rocks, thank you.
- TDC needs to work with Iwi, the business community and residents to develop a long-term master plan for the District - what will the region look, feel and act like in 2050. The LTP is basically an infrastructure plan - we need a greater vision re cultural, economic, social and environmental outcomes for the future.
- Beggars outside my shop are encouraging others to congregate around them. They smoke and eat while sitting on the curb side on blankets asking people for change. Customers are complaining and don't want to walk past them. This is rubbish and council needs to do something about it as it is an organised group. I pay rates and rent to be located on this street, but this is a really bad look for Taupō. I expect this to be addressed urgently.
- Stop the use of non-neutral consultants where surveys are done where results are restricted by terms of reference and scope.
- Council has contrary advice on population and therefore development - sometimes you are planning for consistent growth, other times you say that the population will drop in a decade or so.

You appear to be caught up in too much detail (eg lots of plans but no adherence to them - planning to pedestrianise Tongariro St then putting in more carparks) and not enough common sense (eg traffic lights) or regard for efficient spending (eg tripling rent for TDC staff).

I'm happy to keep the character and amenity of Taupō much as it is, with improvements in quality (eg better traffic flow) rather than quantity (eg no tall buildings in the cbd).

- Keep providing for cultural narrative into our public spaces. Our family and friends who visit are always blown away with the cultural spaces like the atea in town. They want to feel a stronger connection to places they visit, feel inspired and uplifted, and a place that is in true partnership with iwi.
- Spa Hotel area taken better care of for historic reasons. A walkway down the Spa Road Hotel Hill? Walkways around Spa Park fixed and tidied, new playground? I walk this area daily and so do a lot of other locals and tourists, I don't see it getting the attention new subdivisions are?
- Some things are important and if doing them results in rate rises, so be it.
- Encouragement through funding for returnable cups and plates at local cafes as supplied by "Make Waste History". These dramatically reduce landfill from the millions of cups used daily.
- Overall happy with our Councils efforts. Keep up the good work 👍
- Thanks for your work. Just the new developments around Nukuhau. Will be interested to see the stress on infrastructure and facilities.



- Infrastructure must be built before developments and not after, thus the second bridge before any further development North. There is too much new development now without the infrastructure to support it.
- Too much for this box. Work with Climate change action group, Bike Taupō and Greening Taupō. Where are the cycle paths to Waipahihi school from Ngaroto?
- A public toilet at Paetiki Shopping Centre.
- Roads, water pipes and drains.
- Stop treating tribal groups as though they were a special and separate part of the community - they are NOT! Racial preferences are abhorrent and complete inconsistent with our way of life.
- The weekly comments by Councillors is very useful. My thanks to those Councillors who have written comments. Communication with the ratepayers continues to be an issue and in the past public meetings have been suggested. But nothing has been done. Why? The recent new 'timber fence' on the Lake Terrace is very disappointing and a complete waste of ratepayers rates. Why has no Councillor ever spoken to the public as to the reasons why the previous chain railings were not deemed inadequate and had to be replaced? Is this a case of Councillors being 'hood winked' by staff. Staff that have pet projects that they can say are part of the agreed budgets. Governance by Council in 2023 is at risk of being seen as non-existent and that is a worry for our future management of costs and more rate increases. Council failed to the recent 2023 attempt to manage and reduce the rates increase. Sorry, but you will not change my mind on that outcome, as I am one that is paying the extra rates!!

### **KERBSIDE COLLECTION**

- Government website states food bins don't need to be included/introduced until 2027 and only for urban areas of 1000 people or more.
- Very unhappy that kerbside collection changes are being forced upon us as ratepayers when many families use 2 or more bags a week and bin service just wont work.
- Totally against food scrap collection – people already compost in our town.
- Great to have wheelie bins to keep animals out of the rubbish bags, we have lots of wandering dogs around town at the moment.
- Totally support wheelie bins and compost bins.
- Recycling collections needs to be weekly not fortnightly.
- Main comments gathered today were from people who don't want wheelie bins for various reasons: holiday home owners, rural dwellers, mobility users, single people living in a dwelling, large families so will still need to go to the refuse station as a wheelie bin wont have enough capacity.
- Not fit for purpose in Mangakino and not fair that the ones who don't want a wheelie bin can't opt out- we will have to pay universally for something that isn't suitable for many i.e Single people, holiday homeowners, elderly, large families, farming community.

- Although our town centre is well maintained by Ma and the parks team it would be nice to have some more flowers in planters to make our town look and feel attractive again.
- More shops are needed to make Mangakino a desirable place to come to.
- Can we have our town planted more to make it look beautiful.
- Look at reducing speed through our village- some speed bumps around the place. I live in Rangatira Drive not far from entrance to Mangakino and I can assure you that not everyone does the speed limit in or going out of town. Then there's the motor bikes speeding. I feel the speed bumps need to go all the way across the road like on lake road. Our town is getting busy at times, and I just want to keep everyone safe.
- More maintenance of the reserves in Mangakino, mowing times are too far apart especially in spring, height of the grass is too much needs to be lower.

## VILLAGE PLAN

- An opportunity to have some community consultation when the new district plan is reviewed would be great- we live here and would like an input in what can collectively be achieved to better suit our growing community.
- Can we have a loop walking/cycling track from our lake front, up Kinloch Road, Along Whangamata Road, into the stream walk and back along the beach to the lake front- would be ideal for so many people especially families with small children.
- The Kindy project is very exciting, fingers crossed this can happen sooner rather than later.
- Why does our village look so untidy and unloved- long grass along the verges in summer (unsightly and a fire risk), weeds everywhere and weeds on beach.
- Security cameras need to be re located to outside Populars to capture people coming/going from the top of Kinloch Road.
- We need a café/restaurant now Topsy Trout has closed- we have lost our community hub – Kinloch Golf Club are hoping to develop a project to create a community café which would be perfect- it is close to town and easy to access by most people.

## OTHER COMMENTS

- Kinloch is growing very rapidly and needs improved community meeting facilities.
- Having a community garden project at the community hall will be wonderful: social wellbeing, assist with cost-of-living crisis, educational, inter-generational.
- Lower the speed limit in the village to 30kph and put traffic slowing devices on most roads.
- Better playing equipment in the domain.
- Have a weed /broom management plan in a lake for the lake fore shore.
- Cafe at Kinloch golf club would be beneficial for locals and visitors.
- We need more places for our many and varied local community groups to meet. The Kinloch Village Golf Club club rooms could be improved to cater for more community needs. This would also require the conditions of our lease with the council to be updated.
- Our lakefront and pathways are already excellent and any development would need to carefully address the need to maintain our beautiful natural environment.
- Since the “Topsy Trout” restaurant closed there are no alternative venues for social gatherings. The lease restrictions on the Kinloch village golf club could be relaxed so the club rooms can be upgraded to meet the increased need for community groups to meet and hold functions and provide a venue for walkers and golfers to have refreshments.

I feel that since mountain bike operators were allowed to operate in the Kinloch domain, it has put a lot of pressure on boaties to park their trailers. May as an option move the mountain bike operators to Mangakino and free up the domain for boaties, which I may point out have been using the domain for a very long time without any problems until now with the overcrowding of mountain bikers and there vehicles.

Its all very good and well having these idea's and thoughts regarding Kinloch, but at the end of the day who is going to pay for this.

In the time I have been at Kinloch I have seen it grow from a village to a suburb and still growing which I am not happy about, there seems to be new subdivisions going up all over the place which I believe need to stop, once again more pressure on our infrastructure. I think the council needs to create money making ventures to halt the constant rate rises for its ratepayers. If things keep going as they are, I will be packing up our families and shifting to Australia like so many thousands of other kiwis have done.

## **OTHER COMMENTS - BROADLANDS / RIVER ROAD**

- River Road - A safe playground please our kids get splinters on the current one.
- Need a new playground as the current one is old and unsuitable (splinters) and some equipment is broken.
- Need something for older children please i.e spider climbing frame.
- Storm water is a problem so any footpath work with kerbing/channelling must address this too- original drainage does not work when it rains hard.
- Mirror at end of white road as a safety precaution as that is where the school bus stops and lots of trucks going in/out of Permapine. 4 months ago, Tristen from TDC said he would look into getting a mirror for Whites Road but not heard back.
- No development of footpath/cycleway on side of river- privacy of homes WRC.
- Water supply is excellent.
- Water pump on Tiverton Downs Road, scheme was paid for by River Road residents when established @ \$3,000 each- which was a lot of money then, now locals are charged \$587 annually – what will happen when the water reform come in?
- Sewage system along the lakefront across river to new development needs action (Infrastructure).
- There is a need for a recycling collection system – bins? Rotorua Council supplies bins to community in right up to their boundary.
- No hot water in the hall toilets.

## **RANGITAIKI**

- Bus shelters please.
- Why cant we build more homes on our rural land so extended family members can live close?
- Wheelie bin or rubbish collection especially at the school would be great.
- Fly tipping a big issue along SHW 5.
- Could TDC offer any support and advice to the small hall committee who are struggling with Womald/Fire alarm people who carried out \$4k worth of work and have now said more work need to take place- hall cant be used at moment due to this issue and a WOF cant be issued for the hall.
- AED (Defibrator) is needed within the community- especially in light of the area being cut off during cyclone Gabrielle.
- What do the rural rates cover when locals sort their own water, sewages, rubbish etc...



## WAIRAKEI

### *Walking and cycling access and State highway road crossing*

- Annual Plan Request: Access to Waikato River Trails. Possible to get the Community Engagement Team to assist with negotiations with LINZ/Contact Energy/Waikato River Trails to provide linkage.
- Safe access from the village across SHW5 to access the walking and biking trails, currently it is not safe for families to try and cross and has we no longer have a village shop getting safely to BP for milk, bread etc.. is very difficult.
- Contact Energy have indicated they would be keen to assist with clearing the heritage staircase that used to be used by locals to walk to the power station when the village was built, can we make links with TDC and Contact Energy to all work together and make something happen?
- Wairakei villagers need ways to safely exit our village across the highway we don't want to have to drive everywhere.
- Improve access to the bike trails from Wairakei village please and improve bus timetable from Wairakei village to town.
- How cool would it be to get across to the river trail walks with our family safely can we have a crossing across the highway please (Wairakei).
- We would like safe access to the bike trails.
- Wairakei - Wairakei Village is 'road locked' for pedestrians and those on bicycles. Please build footpaths to make safe pedestrian access from both village entrances (SH1 & SH5) all the way to Wairakei BP so we can ride our e-bikes to town and so we can safely access the Waikato River Trails.
- Wairakei - A safer way to cross SH1 and SH5 from Wairakei to be able to walk both down to the power station and into town.
- New footpath connecting Wairakei Village to Wairakei BP please. Coming from both SH1 and SH5 village exits. Re-instate the lighting and clear the weeds on the accessway from Wairakei Village Tawa St to SH5.
- A better pathway along the roadside from Wairakei Village to the BP garage would be great.

### *Village revitalisation*

- Annual Plan Request: Permission to direct the Community Engagement Team to putting together a revitalisation plan for Wairakei Village.
- Please help us make our village beautiful it feels sad and dismal at the moment.
- We want our village to look beautiful and vibrant.
- Footpaths need attention to make them look and feel better.
- Village entrances (both) would benefit from a facelift – that is the 1<sup>st</sup> impression of our village and sets the tone.
- Nature trail with good pathways throughout the village would be great- get locals walking and biking around our village as it isn't safe to walk and bike across the highway with small children.
- Make Wairakei beautiful we have experienced lots of damage with the cyclone which makes the area look very sad.
- Please tidy Wairakei village up it is looking very tatty.
- I would like to see the Wairakei village footpaths upgraded. They are very pitted in areas and my children have tripped on numerous occasions due to the unevenness of them. Tree roots have damaged several areas. Some potholes, one I reported which got filled with gravel and I was told would be repaired but a year on the gravel has all come out and the hole is deeper than ever.



### *Transport*

- Please can you make the crossing outside the school a pedestrian crossing as it is very dangerous at the moment on that busy part of the road.
- Speed bumps as lots of fast traffic through the village especially around the school and playground area.
- Footpaths are cracked and in poor condition throughout our village.
- Better transport connections for people working in town- public transport and safe cycling options.
- Can the trees along SHW5 be cleared as they look terrible following the damage done during the cyclone.
- Can we look at ways to get from our village across SHW5 onto the bike trails- we need a safe way to venture across the busy road as families.
- Please can you look at reducing the speed limit around the village exits especially SHW 1.

### *Recreation and arts*

- Organised sporting activities on our new courts- today was great with some basketball coaching happening – good to see all the kids having some fun.
- Pool please – lots of comments about a village pool.
- Mobile Library.
- There are many children living in Wairakei Village and they would benefit from a better playground.
- Development to the Wairakei park.
- Would love more playground and public tables in Wairakei for the community to spend time outside with families.

### *Environment*

- More trees as our area has lost a lot with the cyclone and looks bland and empty now.
- More trees planted on the berms and oval grass areas.
- Lots of comments on more trees please.
- More native planting please.

### *Community Togetherness*

- We have a lovely friendly community; the old issues seem to have disappeared which is great to see and new energy is developing within the village to all get along.
- Please support our community to be unique – celebrate differences.
- We don't feel part of Taupō- would be good to feel more included and connected- we are land locked by two busy SHW's so feel quite isolated at times with no shop now either.

### *Other comments*

- Annual Plan Request: Access to roundabout. Possible to increase the frequency of mowing on the Tawa St accessway, possible to mend the broken streetlamps on the Tawa St accessway.
- Annual Plan Request: Possible to get the Community Engagement Team to assist with negotiations with LINZ/Waka Kotahi/Waikato River Trails with a view to removing trees blown down by Cyclone Gabrielle in vicinity of the village on SH5.
- Change to mains wastewater and repair at the [poor] foot paths out in the village too [].



- Stop leaving Wairakei to waste away with no help, taking away any business and potential business and talk of removing the school. We are only 8 [] minutes from town and we are a part of Taupō. Why should our rates increase to do things that should be already by covered. So many people in the village own their own homes and are locals and none of our house rates get used for us.

### TŪRANGI RECREATION AND ACTIVITY CENTRE

- Youth Centre for Rangatahi where teenagers can hang out, play pool, listen to music, ping pong that's if recreation and activity centre isn't the same.
- Recreation centre is needed to inspire future athletes as lots of local talent but nowhere to train, practice= no opportunities (5 responses).
- A purposeful recreation and activity/event centre is needed.
- More sporting facilities needed especially with youth opportunities.

### DEVELOP A LONG-TERM PLAN TO REVITALISE TŪRANGI TOWN CENTRE

- Our town centre is terrible, not good for the locals to feel pride and no good to attract tourists.
- We have a huge opportunity to attract tourists/passing motorists to stop and spend time in Tūrangi but it is dismal and not very appealing.
- Make at least a small part of our town appealing- we have some hidden gems that can be showcased i.e art gallery and gift shop in the mall, boutique cafes- look at Tirau it is a thriving little town, why cant Tūrangi or at least a part of Tūrangi be the same?
- Focus on our Cafés and make at least one part of Tūrangi appealing for visitors.
- EV parking.
- More signage- what is on offer eg: Café, RSA, Pools etc.. to draw people off the highway into our town to spend money and help improve the economy.
- Connect all Southern centres and then connect all round the lake.
- Hub space in town for banks and insurance services.
- Shared space options a couple of days a week for Banks/insurance and other service providers.



- Bring Tūrangi up to date. It is shocking to see the town in such a sad sorry state. Yet Taupō get the better deal when we pay rates as well and are on the edge of a national park. This town should reflect the environment for example if Tūrangi was in Europe it would be an established alpine town capturing both the summer and winter tourist opportunities with ski shops, bike shops, artisan cafes, restaurants, gyms, yoga studios. Art centres, local museum, cultural centre, a beautiful hot pool complex offering massages beauty treatments.
- Town centre desperately needs renewal. Locate new toilets and bus stop in town centre. Redesign of town centre needed to make it viable and accessible. Ownership structure needs to be changed such that a body corporate is created in partnership with iwi to ensure the centre is better managed as a whole. Information centre needs reinstating and transferred to town centre.
- Identify the character of the town, encourage business enterprise, eliminate ability to create high density housing, identify a means by which local iwi can develop their own whenua for housing via suitable loan pathways, take a pragmatic look at the future of the town mall, press on with the provision of a fit for purpose community centre.
- Scrub clean the main town centre.
- Please put us further up the Taupō list. The recent improvements to the Taupō Township is most impressive including the plantings and the promotion of Māori Art. Tūrangi is jealous. Please give us the same. Having locals contribute to the art has to give pride to the area.
  - A stage in the town centre for concerts.
  - Not just planting but MAINTAINED.
  - Local artists.
  - Reason for passers by to stop and call in.

Can a measure be made of the amount of traffic that merely passes through without stopping? We need a reason for them to stop and call in. Please do not consider per population but rather the potential custom we could draw!

The area has so much history. Please include this and make this a township we can be proud of ... it's currently embarrassing.

- Collaborate with banks to offer a banking hub in Tūrangi. A place banks can use once a month or so to offer the one on one services we are so desperately missing. If we can start with banks then maybe other businesses eg mortgage brokers, insurance brokers etc will follow for our Whānau that can not travel to Taupō.
- Improve our town centre, more shops and create jobs (9 responses).
- Colourful murals in town, created by youths.
- Nice mall with interesting shops: Sushi, Tank, fruit shop, seafood, McDonalds, KFC, Starbucks.
- Cinema (6 responses).
- Library that is more interesting to visit.
- Open the town centre up it feels dark, unsafe and boring.
- Specialist shops i.e. Butcher, hunting and fishing, clothing, shoes.
- Interesting businesses i.e. zoo, aquarium, arcade.
- Ram raiding proofing our shops.
- Town centre looks very tired and shabby, a wash and paint job would enhance the shopping centre, lots of comments like this.
- Lots of empty shops- makes the town centre look very sad and neglected.
- Some new shops would enhance the town ie shoes shop, furniture, clothing etc...

- The underpass, I will always remember fondly as a kid riding my bike down and up but it's been neglected for the last 30 years, rundown and so unsafe.
- Underpass needs a facelift and lighting – it feels very unsafe at the moment.
- Underpass -could youths spruce it up to give them a sense of ownership and pride.
- Underpass needs drainage options- false floor (over water) and level floor.

### **DEVELOP PLAN TO REPLACE CURRENT PUBLIC TOILETS**

- Toilets are needed by the bridge at a Tūrangi where fishermen and river walkers emerge from beside the river. This should be a high priority.
- Another public toilet automatic self-clean 24 hours. Closing at 7pm is ridiculous in Tūrangi!
- Could we please see more public toilets or access in Tūrangi I'm tired of watching people using the gardens in the town centre.
- Yes demolish the old block toilets behind Te Mataapuna at Tūrangitukua Park they are dirty & disgusting.
- Public toilets need refreshing and maybe a shower option for homeless.

### **MORE FREQUENT BUSES TO TAUPŌ**

- The connect bus Taupō - Tūrangi needs expanding. I heard multiple times that it is unable to take all the passengers on the day. My suggestion is that it is expanded to a daily service until Dec 1st. Then to keep adding trips as needed eg one leaving Taupō to Tūrangi 12.30pm and return 6pm (this will enable tourists to connect to half day experiences in Tūrangi eg Rafting, Horse trekking without driving themselves) also consider 2 late nights Taupō to Tūrangi to enable Tauhara and Nui High school students from Tūrangi to participate in afters school activities. I would also approach Tongariro Xing transport businesses based in Tūrangi if linking to their transport over summer would alleviate some pressure on the carpark at Ketetahi road end.
- Bus is now too small, nit everyone gets a chance to board and get left behind, we also need the bus 3 times a day please.
- Immediate and urgently need a larger bus- at least a 20 seater for the Tūrangi-Taupō route- currently 11 seaters are in adequate to meet the demand.
- Buses after 5pm and before 7am please to meet the demand.

### **SH1 ROUNDABOUT**

- Build a roundabout in the Tūrangi highway intersection into the town centre.
- I think a roundabout at the Tūrangi intersection would slow traffic right down and make it safer for vehicles to cross the highway to Atirau Rd.
- Build a roundabout in the Tūrangi intersection.
- The main intersection into Tūrangi town off SH1 needs serious reconsideration. It's dangerous, I often have to turn from SH1 to Te Arahori and you have no view of oncoming traffic if there are cars waiting to turn into town. I've seen multiple near misses in the last 2 weeks, let alone a few crashes in the decades I've lived year. A roundabout would solve a majority of our issues. A roundabout would reduce speeds around that intersection and encourage people to turn into town more often.



## WALKING AND CYCLING

- Install more bike stands by Hong Kong takeaways (Tūrangi).
- Check footpaths and gutters. Footpaths are worn down which makes walking on them rough and gutters are crumbling in some places. Some gutters have grass and weeds growing in them which prevents water running freely.
- Shared walking and bike track to Lake Taupō.
- More, better cycle, walking tracks to encourage tourism.
- More bike stands under cover.
- A continuous foot path along SH1 in Tūrangi from the southern end of a Taupahi Road to the Tongariro bridge.
- Improve the footpaths and safety along the Tongariro Bridge. For example there is no safety barriers as you walk along the bridge, no yellow warning information to let traffic on a main highway that people do walk along the bridge cross the road to start the river trail.

Traffic speeds nearly taking you out or big trucks blowing you off the bridge!

- Walking and cycling track from Tūrangi to Lake Taupō. The best route is adjacent to the Waiotaka River.
- Cycle, walking track required between Tūrangi and Tokaanu Wharf. State highway is extremely dangerous as there is no shoulder. Track could also be built out to stump bay as this is only safe swimming spot at Tūrangi end of lake. These would be good for tourism for Tūrangi.
- We live in Tūrangi and would love to see some decent cycle trails in our area.
- Cycle Walkway surrounding Tūrangi. Could have decent paths across the Tūrangi sports field connect up to Hirangi Rd down to the Tokaanu Tailrace bridge back up the main road to Atirau Rd back to SH1 head both ways north and south, south to Taupahi Rd connect to Tongariro river trails and north to Tongariro river bridge/Bridgelodge and back to join Hirangi Rd again. Always new pathway/cycle way happening around Taupō and nothing decent for Tūrangi.
- Build cycle trails in and around Tūrangi. We see all the flash trails being built in Taupō but nothing for Tūrangi.
- Priorities Walkway Cycle ways in and around Tūrangi.
- A boardwalk through to Motuoapa, with education on our big Wetland. If it runs from Tūrangi through Stump Bay to Motuoapa it will create another cycle adventure and connect Tūrangi to the lake.
- Handrail on the bridge (to separate pedestrian from traffic).
- Cycle tracks- good concrete paths (like Taupō) Tūrangi to Motuoapa which would support cafes and food trucks.
- Cycleway/walkway circuit around the town: Hirangi Road, Tokaanu straight, River trails.
- River trails- partnership investment and maintenance.
- Footpath from Tūrangi to Tokaanu – boardwalk through the wetland areas.
- Bike trail from Taupō to Tūrangi would be good.
- Cycle way to Stump Park with boardwalks over wetland- major opportunities.

## HOUSING

- Set up a Monte Vista residence in Tūrangi so our kaumatua don't have to be away from whanau in Taupō.
- Homes should be warm and dry.
- More affordable housing so our whanau can live close to us.



- More housing options at our maraes so we can stay together and support each other better.
- Build homes like Taupō in Tūrangi (make use of the wasteland).
- Affordable homes for our future.

## ENVIRONMENT

- I have put low priority on the above because more important and improvements are needed in Tūrangi.
- More rubbish & recycle bins in public areas.
- Tūrangi - More rubbish bins on the outskirts of Tūrangi town centre as the mall area doesn't cut it.
- Buses need to be electric and run continuously, which if they are electric, they can do - same as the Wellington ferries. We need to make sure all services work before we go adding any further infrastructure to our town; make sure that all we have is as good as it can be and renovate anything that needs renovating. Needs - not wants.
- More bins around the town centre to maybe help with the litter problem.
- Keeping it clean and tidy for all the visitors we get.
- Tūrangi residents cannot afford rates hikes for some of these issues. We already pay too much for power due to just one lines company and a power station next door.
- Tūrangi - Improve dealing to the leaves and gutters in Tūrangi.
- Rubbish bins needed on river trail.
- Food scraps collected should go to community gardens in each area of Taupō.
- Rubbish bins V bags in Omori/Kuratau/Pukawa – Issues!!
- Community garden (3 responses).
- More trash bins around town (8 responses).
- Clean up glass in town centre.
- More outdoor activities- learning about our environment.
- Fix water issues (Plumbing).
- Lake erosion is a major concern, people feel the weather pattern will no doubt get worse so lake will continue to be high resulting in more erosion especially around Tūrangi/Omori- Kuratau.
- Keep the lake safe. no more trucks spilling their loads in the lake.

## RECREATION AND ARTS

- Bring Tūrangi up to the same standards as Taupō.
- What about Tūrangi?
- Tūrangi.
- The smaller communities in our region need continual addressing. Tūrangi and Mangakino. This shouldn't incur an 'increase' of rates, but it should be what happens to bring the smaller towns and communities to at least an equal standing and point of priority to that of Taupō.
- A small pump track as extension to the playground.
- Pump track or little bike track for kids (somewhere safe to ride).
- Tūrangi splash park- with shade options- next to Turtle pools.
- Art by locals installed around the town to represent our people/local story telling – graffiti may diminish if locals take ownership of art around the town.
- Promote trout fishing as it is a real drawcard for Tūrangi.
- Weekend sports/organised sports (3 responses).



- Upgrade our basketball courts – fencing and lights (10 responses).
- New nets for our town centre hoops.
- Lighting around the skate park.
- More sections and lighting on the skatepark.
- More public pools.
- New netball pavilion.
- Somewhere to ride my motorbike -safe site (8 responses).
- Motorbike racing.
- Horse-riding events.
- Outdoor gym (9 responses).
- More activities held on the side of the lake.
- Outdoor pool/hot pool with sunbeds.
- Better built park at Te Kapua Park.
- Electric scooters.
- Dog exercise park.
- Water fountains for human and dogs.
- Arts and culture facilities; dance studio, painting studio, roller skating.
- Christmas in the park event.
- Lots of praise for the new playground and sports hub work, locals were very grateful.
- Improve our public swimming pools.
- Cheaper swim for locals at swimming pool so they can be better used throughout the week.
- Community garden project would be amazing- healthy living, cost of living crisis, social wellbeing, cooking workshops could then be developed.
- The pools opened earlier for those that like to. Go swimming before school.
- Increased public access to Tokaanu hot pools e.g. buses during busy times.

## **TRANSPORT**

- Fix potholes on our roads (5 responses).
- More frequent buses to Taupō especially for elderly and young.
- Safe way to cross the highway is needed, i.e underpass.
- SH1 from Tūrangi to Taupō needs attention.
- Pedestrian/cycle lane over the river bridge just outside town centre as it is not safe at present.
- Create a bike trail to Tokaanu wharf but need to invest in a safe bike lane as road is very dangerous with lots of heavy trucks.
- Old Tokaanu wharf needs a big clean up if tourist, cyclists are being encourages to go there, it is very smelly.
- Roads are fast and dangerous- especially for older drivers.
- We urgently need an alternative to Buller Point.
- Improve potholes especially on SHW 1.

## **PARKS AND RESERVES**

- Reserve by the bridge needs some investment- planting/picnic tables.





- Make gardens more appealing.
- Have gardening team based in town so they can keep the place looking tidy.
- Why can't we have beautiful gardens like Taupō?
- Autumn leaves are a problem- blowing into houses, gardens and shops- continual job clearing them.
- Dog bins and NO DOG signs on sports fields – health and safety issue at present.

## OTHER

- Positive feedback on Kerbside collection proposals from those at the Tūrangi market.
- High petrol prices are a real issue.
- Major services are all in Taupō.
- Māori wardens- friendly and effective.
- More police and dog handlers to keep us all feeling safe.
- CCTV in, out and around town.
- Council comms could be improved for Tūrangi (Connect with a focus on what is happening in Tūrangi).
- Investment in free initiatives for tamariki needs to be a priority too, especially in places like Tūrangi. The park is a great start, but they need to have more options. As someone who grew up here, it's boring and you can see why tamariki end up going down bad pathways, especially if they are in environments which they aren't supported.
- I believe local council need to look more at macro level interventions that straddle economic, people and environmental wellbeing outcomes. I believe this could be better achieved by taking a unified, holistic approach to all matters related to council 'business' and must start by true co-governance structures as the problems of environmental degradation will only be made worse if not addressed NOW and the problem is too big for one body to address alone.
- Access to the river and encouragement of public services and reserves closer.
- Entertainment, before/after-school care for children.
- Early childhood care for 1–5-year-olds.
- Upgrade Tokaanu wharf.
- Return to display model of Tongariro Power Project to local information centre, many visitors are wanting to know about the project. Also return fly fisherman to main road. Restore sign to entrance at main road, Tūrangi town of all seasons, and Tūrangi trout fishing capital of NZ.
- If we are to pay more rates for improvements in Tūrangi, do we still have to fund improvements for Taupō? If the answer is yes, then wouldn't we be paying more than those who live in Taupō? Should this not be paid by everyone who lives in this rohe, not just by those who live in Tūrangi? I might need some clarification around this.
- Tūrangi residents shouldn't have to be paying MORE rates. They need to be included in the rates that we already are currently paying, and it should be a priority of the council to bring our community and town up to the standard they would expect and provide to Taupō.
- Leaves, gutters, roaming dogs (and cats), crime, vandalism, town centre, young people activities funding, oh! and roaming dogs.
- Create a Matariki Festival for Tūrangi, Taupō has the Winter Festival but with the Co governance with Tūrangitukua we can create an amazing product that will lift Tūrangi spirits and create a unique festival for the Southern End.
- A tidy up on the Hīrangī Rd carpark for Tūrangitukua Park or at least a more frequent cleaning process at it always floods throughout winter.
- Senior Citizen Hall - Signage needed, Needs a facelift.

### EASTERN BAYS (HĀTEPE, MOTUTERE, MOTUOAPA, TAURANGA-TAUPŌ)

- Upgrade playgrounds - they're boring as.
- A few local bins at parks in Motuoapa.
- Eastern Bays - Cycleways and more public transport connecting our smaller communities (i.e. southern to the northern end).
- Mixed aged play equipment in each smaller township, Motuoapa has very copy paste playgrounds.

### WESTERN BAYS (OMORI, KURATAU, PŪKAWA, WHAREROA)

#### *Accessibility*

- In areas that are NOT Taupō more accessibility from road to footpath etc., for wheelchairs, buggies etc. Same for entrances to lakeside areas. Better cycleways, walking paths NOT in Taupō. TDC does not just mean Taupō, it means all the areas that you collect rates from.
- In Omori - Improve access to the footpaths for wheelchair users.
- Remove grass from the footpath in the Omori area. The footpath is too narrow for my powered wheelchair.
- Fix the uneven footpaths especially the cobbles going up the hill to the Omori shop.
- Give access to the public toilets for wheelchairs.

#### *Environment*

- Lake front erosion – the people who caused the problem should pay for the fix, not council or ratepayers. WRC (Who gave consent) and Mercury Energy should be held accountable.



- Erosion on lake front – restoration work needed, advocacy work to improve communication with locals so they know what is happening.
- Gum trees on WhioWhio reserve – is there a maintenance/felling schedule as these trees are dangerous.
- Need to keep on top of small maintenance tasks i.e. Blackberry, Weeds to keep the area looking nice and appealing.
- Grass overgrown by boat ramp needs attention.
- Omori Lakefront needs to be future proofed with regards to erosion very concerning for us all.

### *Transport*

- Potholes need fixing throughout the village roads.
- Footpath maintenance.
- Let downs for wheelchairs mobility scooters and pushchair users.
- Speed restrictions in our village especially near the playgrounds- this has been raised by the community several times, but nothing has happened.
- Good bus network from village to Taupō.
- Designated parking at Omori reserve playground to stop cars driving onto play area.
- Improve fencing around the playground for H/S reasons and to protect the grass from being ripped up with vehicles driving over it.
- Heavy equipment/vehicles are ruining people's property.
- The intersection at Pihanga RD/ Te Puke Rd was altered about 5 years ago and is more dangerous that it was before, so if you are going to do something about Waipapa St/ Pihanga Rd please ensure that it is safe, at the moment you have to come out of Huihuiawai St quite a way before you can see down Pihanga Rd.
- Omori Kuratau Ratepayers Assoc has also asked for the speed limit going up to the refuse station to be altered, again no response from TDC.

### *Recreation*

- Fitness circuit for summer crowds
- More playgrounds in Omori- holiday homes are ratepayers too and deserve adequate level of facilities- lots of responses with regards to this topic
- Playground by the lake front is like a swamp due to heavy machinery churning up the ground.
- The parking of boat trailers on Pihanga Road on both sides of the road and footpath above the Kuratau boat ramp, on the hill, during the holiday season is dangerous.  
There needs to be designated parking and a fence on the road frontage at the Omori Reserve playground.
- Omori Kuratau Ratepayers Assoc has asked repeatedly for designated parking at the Omori Playground and fencing to stop cars driving onto the reserve. This is a safety issue, but we keep getting fobbed off.
- More playgrounds as all the homes in Kuratau
- Better signage for public access to pathways
- Regular maintenance of pathways around the village- to keep them safe, accessible and tidy.
- Accessibility toilets i.e. wheelchair access and changing room.
- Make lakefront accessible for wheelchairs/pushchairs/mobility scooters.
- Improve fencing around the playground.



- Do the upgrades that keep being promised i.e. tennis courts.
- More appealing entrances to the village – get rid of the blackberry bushes.
- Drainage on the lakeside reserve at Pukawa. Improvements to stormwater runoff at lakeside reserve Pukawa. Improvements to wastewater overflow in heavy rain events by Pukawa foreshore stream.

#### *Housing*

- Kuratau can't support 80 or more houses next to parks and river.

#### *Water*

- Infrastructure needs upgrading, lots of broken pipes due to heavy construction vehicles driving over them fully loaded with materials to repair lake front i.e. Rocks.
- Frequently broken water pipes and boil water notices – these needs addressing as a priority.
- Ground was ripped up when laying a water pipe which was never fixed properly.
- All water pipes need to be upgraded and replaced as a matter of urgency – lots of responses about this topic.
- The current long-term plan already states that our drinking water is up to specification.

#### *Recycling:*

- Are wheelie bins suitable for holiday homes?

#### *Other comments*

- Would be nice to get a response from service requests when they are logged.
- I consider that the latest increase in my rates is excessive and should cover any improvement work necessary in this area. The destruction of the foreshore is caused by keeping the lake level too high!! The great “powers” that have control of the lake levels are making huge money by raising the lake levels when they want to. The bottom line is GREED!! And then the council spends mega amounts of time and money doing senseless “fix-ups” - ie putting thousands of truckloads of sand dumping which is washed away on the same day or week. I have seen this done three times during the last 15 years and have lost all respect for the council using ratepayers' money for their incompetence. A “pumice roadway” has been constructed for the second time along the shore between the Kuratau River mouth and the end of Pihanga Rd.- but no drain was put in at the Kuratau River mouth end, so it immediately started to wash out!!! This is such BASIC construction knowledge - BUT- it's not being done properly so it has to be redone and redone- I despair about the lack of intelligence of the handlers of my rates money!!
- We just want same level of service as Taupō we pay rates too. We would like nice planting areas.
- I think it's pretty bad that council would put our rates up to deal with these issues at the southern end of the lake. Do Kinloch, Wharewaka, Acacia Bay or any other houses close to the lake pay more rates for these issues??
