Hi Hana

Thanks for returning my call earlier. My notes of this meeting are as follows:

- MoE understands the projection of primary aged children will remain stable for the next 6 years, before slowly declining.
- Nearby schools are mostly full or near-full, but that is not the catalyst to planning a new school. Future growth of school aged children is the catalyst.
- I explained that this proposal is not a subdivision – it is to re-zone land. It is therefore difficult for us to advise the timing and staging of sections to the market. As such, it is difficult to comply with your request (as per your submission) to engage early with the Ministry in terms of staging and timing.
- You've suggested that instead of the above 'relief sought' that you might be better off building into the MoE 2023 long-term plan an internal 'monitoring check'.

If you would please confirm this is an accurate reflection of your position would be much appreciated.
