Renewal of Managers Certificate under Sale and Supply of Alcohol Act 2012

Applicant: Tiffany Lee Hunt **Certificate number:** 20/CERT/2968/2022

Please find attached your renewed Manager's Certificate that has been granted by the Taupō District Licensing Committee, along with copies of the relevant reports.

I wish to draw your attention to Section 214 of the Sale and Supply of Alcohol Act 2012 which states:

214 Manager to be on duty at all times and responsible for compliance

- (1) Except as provided in Section 215, a manager must be on duty at all times when alcohol is being sold or supplied to the public on any licensed premises.
 - (2) A manager on duty on any licensed premises is responsible for-
 - (a) the compliance with and enforcement of-
 - (i) the provisions of this Act; and
 - (ii) the conditions of the licence in force for the premises; and
- (b) the conduct of the premises with the aim of contributing to the reduction of alcohol-related harm.
- (3) At all times while a manager is on duty on any licensed premises, the full name of the manager must be prominently displayed inside the premises so as to be easily read by people using the premises; and the person named as manager at any time is to be treated for the purposes of this Act as the manager at that time.
- (4) At all times when alcohol is being sold or supplied on licensed premises the licensee must take all reasonable steps to enable the manager to comply with this section.

Your Manager's Certificate <u>does not</u> need to be displayed in a licensed premises but must be available for viewing by the Police or a Licensing Inspector. This may be checked as part of random compliance inspections by either the Police or Alcohol Licensing Inspectors.

The Application:

This is an application by Tiffany Lee Hunt for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 7th September 2023.

Reasons for the Decision

- 1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
- 2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
- Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability
 of the applicant, nor do they oppose the renewal of the certificate. Accordingly, the application can be
 dealt with on the papers.
- 4. The application and supporting information satisfies the Committee that the criteria we must have regard to as set out in Section 227 of the Act have been met.

Decision of the Taupō District Licensing Committee:

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 approves the application by Tiffany Lee Hunt for the renewal of a Manager's Certificate.

The certificate is renewed for a further period of three years from the date of expiry of the current certificate.
