DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

Friday 21 April 2023 from 10.00am to 5.00pm; Saturday 22 April 2023 from 10.00am to 5.00pm; & Sunday 23 April 2023 from 10.00am to 4.00pm.

- 2. <u>Tasting samples of 5ml in 25ml size tasting cups will be provided, and patrons are only permitted to taste</u> <u>a maximum of five samples each</u>.
- 3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stand (number 252).

- 5. The Licensee must display:
 - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence is to be attached to the stand so as to be easily read by people attending the licensed area.
