DECISION OF THE TAUPO DISTRICT LICENSING COMMITTEE

The Application

This is an application by **Taupo Cosmopolitan Club Incorporated** for an On-Site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the **RSA Taupo Breakfast & Anzac Day Commemorations.** It was formally received by the Taupō District Licensing Committee on 22nd March 2023.

- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.

- 6. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

The licensed premises known as the Taupo Cosmopolitan Club Incorporated situated at 5 Taniwha Street, Taupo, is more precisely identified as outlined in the event site plan provided with the application, as received by the Taupo District Licensing Committee on 22 March 2023.

Section 22 and 64, Sale and Supply of Alcohol Act 2012
