On Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Lake Taupo Yacht Club Incorporated** is authorised to sell and supply alcohol, on the premises situated at 9 Ferry Road, Taupo, and known as Lake Taupo Yacht Club for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **Love Taupo Evening/Michael Priscilla Wedding/See Application.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

- Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: Tuesday 22 August 2023 from 4:30pm to 8:30pm ("Love Taupo" Marketing Evening); Saturday 26 August 2023 from 3:30pm to 11:55pm (Michael & Priscilla Wedding & reception) Saturday 2 September 2023 from 5:00pm to 11:55pm (Italian Classic Car Club Dinner); & Sunday 3 September 2023 from 11:30am to 3:00pm (Lake Taupo Yacht Club Fathers Day Lunch).
- 2. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 3. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 4. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard
- 5. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages
- 6. The Licensee must display signage as follows:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
 - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
 - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

DURATION

This licence is only in force as specified in Condition 1.
