The Application

This is an application by Lammermoor Distillery Limited for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Equifest 2023. It was formally received by the Taupō District Licensing Committee on 23rd August 2023.

Reasons for the Decision

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.

Only 5-7ml tastings will be provided and full bottles can be purchased for off-site consumption.

The Police and Medical Officer of Health reports raise no matters in opposition.

The Decision

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the tastings and sale of alcohol for off-site consumption to any person attending the following occasion or event (or series of occasions or events): Equifest 2023.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

Off Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **Lammermoor Distillery Limited** is authorised to sell and supply alcohol, on the premises situated at 114 Rapids Road, Aratiatia, Taupo, and known as National Equestrian Centre for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Equifest 2023.**

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold on, or delivered from, the premises for consumption off the premises, or supplied as a sample for consumption on the premises, only on the following days and hours: **Friday 13 October 2023 from 8.30am to 6.00pm; Saturday 14 October 2023 from 8.30am to 6.00pm; & Sunday 15 October 2023 from 8.30am to 3.00pm.**
2. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
3. A certificated manager must be on duty at all times, within the licensed area (stall number A44), when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stall.
4. The Licensee must display:
 - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
 - b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area,

DURATION

This licence is only in force as specified in Condition 1.

THE LICENSED PREMISES

The licensed premises known as "National Equestrian Centre 114 Rapids Road Rotokawa" situated at 114 Rapids Road, Aratiatia, Taupo, is more precisely identified as outlined in the Event Site Plan provided with the application, as received by the Taupo District Licensing Committee on 23rd August 2023.
