### The Application

This is an application by Montana Catering 2001 Limited for a on site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the 2024 ITM Taupo Super400. It was formally received by the Taupō District Licensing Committee on 14th February 2024.

#### **Reasons for the Decision**

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.

This a large scale, and potential high risk, event. Up to 20,000 patrons are expected each day and intoxication levels must be overtly managed.

The Police and Medical Officer of Health reports raise no matters in opposition and have worked closely with the Inspector and the applicant to draft up a suite of recommended conditions.

## The Decision

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): 2024 ITM Taupo Super400.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.

# On Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, Montana Catering 2001 Limited is authorised to sell and supply alcohol, on the premises situated at 463 Broadlands Road, Taupo and known as Taupo International Motorsport Park and Events Centre for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): 2024 ITM Taupo Super400.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### **CONDITIONS**

This licence is subject to the following conditions:

Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:

Corporate Bars: Friday 19 April 2024, Saturday 20 April 2024, and Sunday 21 April 2024: From 11.00am to 15 minutes after the final practice/ race of the day.

Public bars: Friday 19 April 2024, Saturday 20 April 2024, and Sunday 21 April 2024:

From 11.00am to 30 minutes before the final practice/ race of the day.

The special licence for the entire venue will operate from 11.00am to 7.00pm.

- Alcohol Sales All bars will start with a maximum of four alcoholic beverages per person. No patron is to hold more than four alcoholic
- At all bars, no patron is to be sold more than two units of Wine or the Woodstock Bourbon & Cola 440ml can product at any one time. 3.
- Serves will be reduced from four alcoholic beverages per person to two alcoholic beverages per person at 3.00pm on Friday 19 April 2024, Saturday 20 April 2024, and Sunday 21 April 2024.
- When the service size of 'regular' drinks reduce from four to two at 3.00pm on Friday 19 April 2024, Saturday 20 April 2024, and Sunday 21 April 2024, then Wine and the Woodstock Bourbon & Cola 440ml can product service size is also reduced from two serves per person to one serve per person.
- When serve sizes reduce throughout the event the appropriate signage must be displayed with the current serve allowance.
- Alcohol may be sold/ served in the following types of containers only: Retail Areas Alcohol is to sold in cans or plastic vessels. Corporate Areas: Alcohol is to be served in glass, cans or plastic vessels. Guests are provided with plastic vessels to decant beverages into when moving outside. No glass is permitted in the outside areas.
- The following types of alcohol can only be sold at the event: Beer, Craft beers, Wine, Sparkling wine, Ciders and a selection of premixed RTD products. No free-pour spirits will be sold at the event.
- Drinking water must be freely available at all bar areas.
- A certificated manager must be on duty at all times at each bar facility, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 11. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard.
- 12. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages
- 13. The Licensee must display signage as follows:
  - At all points-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
  - A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty,
  - The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.
- Police have the ability to change alcohol service sizes, or to close all or any bar/s at any time based around crowd behaviour. These decisions will be based on hourly review meetings with Montana Catering 2001 Limited, the Taupo Police, the Taupo District Licensing Committee Inspector, the Medical Officer of Health representative and the Concert Promoters.

## **DURATION**

This licence is only in force as specified in Condition 1.

# THE LICENSED PREMISES

The licensed premises known as the 2024 ITM Taupo Super400, located at the Taupo International Motorsport Park & Events Centre, 463 Broadlands Road, Rotokawa, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 7 March 2024.
