# **Off Site Special Licence**

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **LWF Distilling Limited** is authorised to sell and supply alcohol, on the premises situated at The Taupo Home & Garden Show 2024, The Great Lake Centre, 5 Story Place, and known as The Great Lake Centre, 5 Story Place, Taupo for consumption off the premises, to any person attending the following occasion or event (or series of occasions or events): **Taupo Home and Garden Show 2024**.

The authority conferred by this licence must be exercised through a managers or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

## CONDITIONS

This licence is subject to the following conditions:

- Alcohol may be sold and supplied for consumption on the premises only on the following days and hours: Friday 12 April 2024 from 10.00am to 5.00pm; Saturday 13 April 2024 from 10.00am to 5.00pm; & Sunday 14 April 2024 from 10.00am to 4.00pm
- 2. <u>Tasting samples of up to 5ml of alcoholic spirit (with a simple mixer of lemonade of ginger ale) in tasting cups be</u> provided, and patrons are only permitted to taste a maximum of four samples each.
- 3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 5. The Licensee must display:
  - a. At every point of sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,
  - b. If so directed a copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

#### DURATION

This licence is only in force as specified in Condition 1.

#### THE LICENSED PREMISES

The licensed premises known as the LWF Distilling situated at stand number 325 at The Great Lake Centre, 5 Story Place, Taupo, is more precisely identified as outlined in the "Taupo Home & Garden Show 2024 Event Site Plan" provided with the application, as received by the Taupo District Licensing Committee on 28 February 2024.
