The Application

- 2. Tasting samples of 20ml may be provided, and patrons can only be supplied with a maximum of two samples each.
- 3. While alcohol is being supplied as a sample, water is to be provided to patrons free of charge at the place where the samples are being supplied.
- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed at the stand (number 340).
- 5. The Licensee must display:
 - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons,

b. A copy of the licence is to be attached to stall so as to be easily read by people attending the licensed area.

The licensed premises known as Q-Liquid, situated at 5 Story Place, Taupo, is more precisely identified as outlined in the "Taupo Home & Garden Show 2024 Event Site Plan" provided with the application, as received by the Taupo District Licensing Committee on 11 March 2024.

The licence shall be subjected to mandatory and discretionary conditions as detailed in the attached licence.
