### The Application

This is an application by Cardrona Distillery Limited for an off site Special Licence pursuant to Section 138 of the Sale and Supply of Alcohol Act 2012 for the Taupo Home & Garden Show 2024. It was formally received by the Taupō District Licensing Committee on 13th March 2024.

### **Reasons for the Decision**

The applicant appears to be a responsible entity to hold a Special Licence and a certificated manager will oversee the sale, supply and consumption of alcohol.

The Police and Medical Officer of Health reports raise no matters in opposition.

### The Decision

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant a Special Licence authorising the sale and supply of alcohol to any person attending the following occasion or event (or series of occasions or events): Taupo Home & Garden Show 2024.

- 4. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the stand (number 252).
- 5. The Licensee must display:
  - a. At every point-of-sale, signs detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons;
  - b. A copy of the licence is to be attached to stand so as to be easily read by people attending the licensed area.
