# On Site Special Licence

Section 22 and 64, Sale and Supply of Alcohol Act 2012

**Pursuant** to the Sale and Supply of Alcohol Act 2012, **Taupo Car Club Incorporated** is authorised to sell and supply alcohol, on the premises situated at 475 Centennial Drive, Taupo, and known as Taupo Car Club for consumption on the premises, to any person attending the following occasion or event (or series of occasions or events): **Multiple Motor Sport Events**.

The authority conferred by this licence must be exercised through a manager, or managers, appointed by the licensee in accordance with Subpart 7 of Part 2 of the Sale and Supply of Alcohol Act 2012.

#### CONDITIONS

This licence is subject to the following conditions:

- 1. Alcohol may be sold and supplied for consumption on the premises only on the following days and hours:
  - 2024 ITM Taupo Super400 event: 19, 20 & 21 April 2024, from 10.00am to 7.00pm on the listed dates.

Taupo Car Club Motorsport Winter Series:

- 15 June 2024 from 3.00pm to 10.00pm; 16 June 2024 from 3.00pm to 9.00pm,
- 27 July 2024 from 3.00pm to 10.00pm; 28 July 2024 from 3.00pm to 9.00pm,
- 17 August 2024 from 3.00pm to 10.00pm; 18 August 2024 from 3.00pm to 9.00pm.
- 14 September 2024 from 3.00pm to 10.00pm; 15 September 2024 from 3.00pm to 9.00pm.
- 2. There is to be a limit of two alcoholic drinks per person per serve.
- 3. The entire licensed area is to be designated as a Supervised area. The licensed area is identified on the site plan date stamped as received by Taupo District Licensing Committee on 12 March 2024.
- 4. Drinking water is to be provided to patrons free of charge from a water supply prominently situated on the premises.
- 5. A certificated manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed.
- 6. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence, or menu variations of a similar range and standard
- 7. The licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages
- 8. The Licensee must display signage as follows:
  - a. At every point-of-sale detailing restrictions on the sale and supply of alcohol to minors and intoxicated persons.
  - b. A copy of the licence attached to the premises so as to be easily read by persons attending the premises,
  - c. A sign prominently displayed at the premises, which identifies by name the manager for the time being on duty.
  - d. The licensee must provide information and advice about forms of transport available to patrons from the licensed premises.

#### **DURATION**

This licence is only in force as specified in Condition 1.

#### THE LICENSED PREMISES

The licensed premises known as the Taupo Car Club Incorporated situated at 475 Centennial Drive, Taupo, is more precisely identified as outlined in the event site plan provided with the application as received by the Taupo District Licensing Committee on 12 March 2024.
