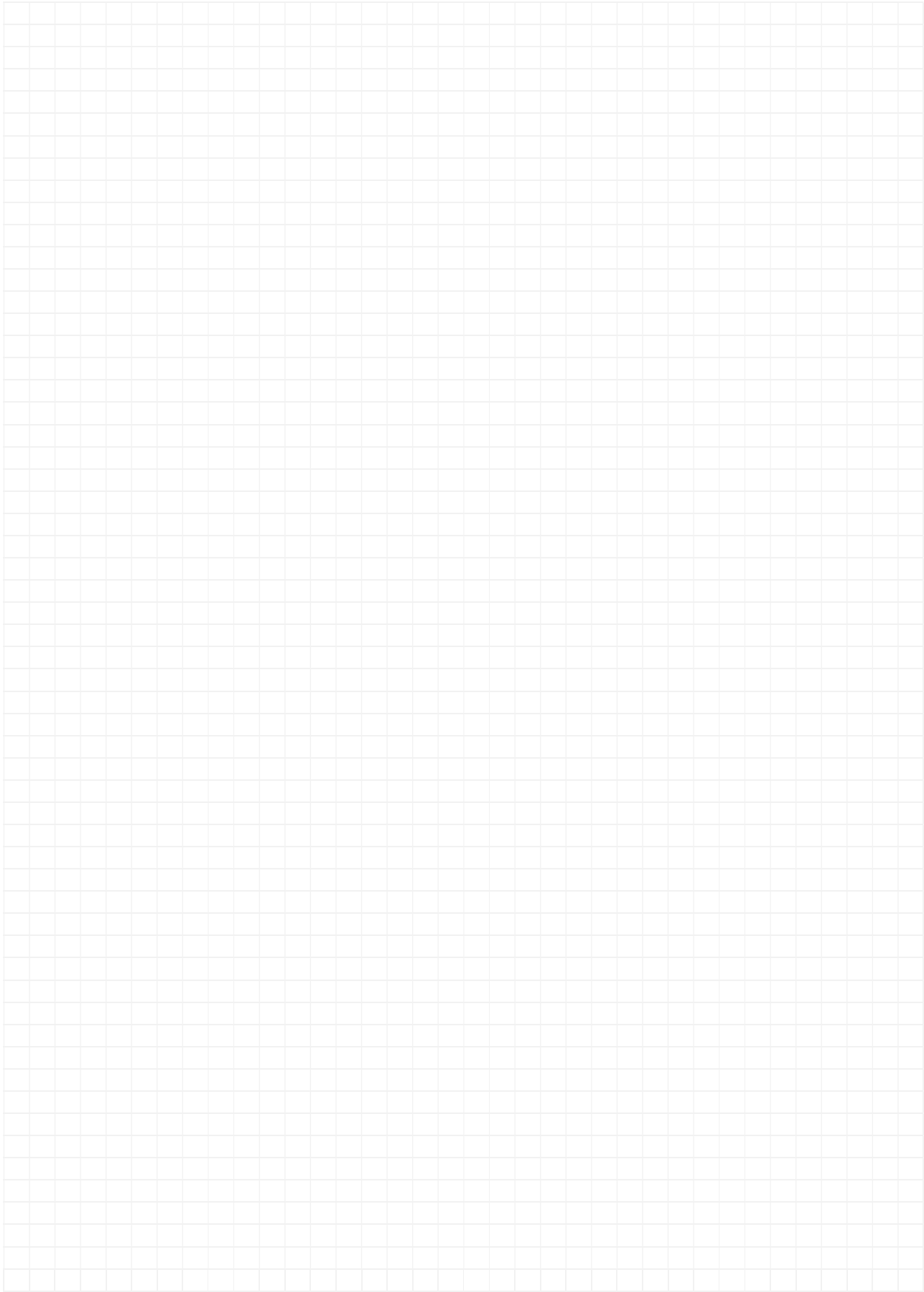
DRAW PLAN IN BLACK BALLPOINT ON GRAPH OPPOSITE

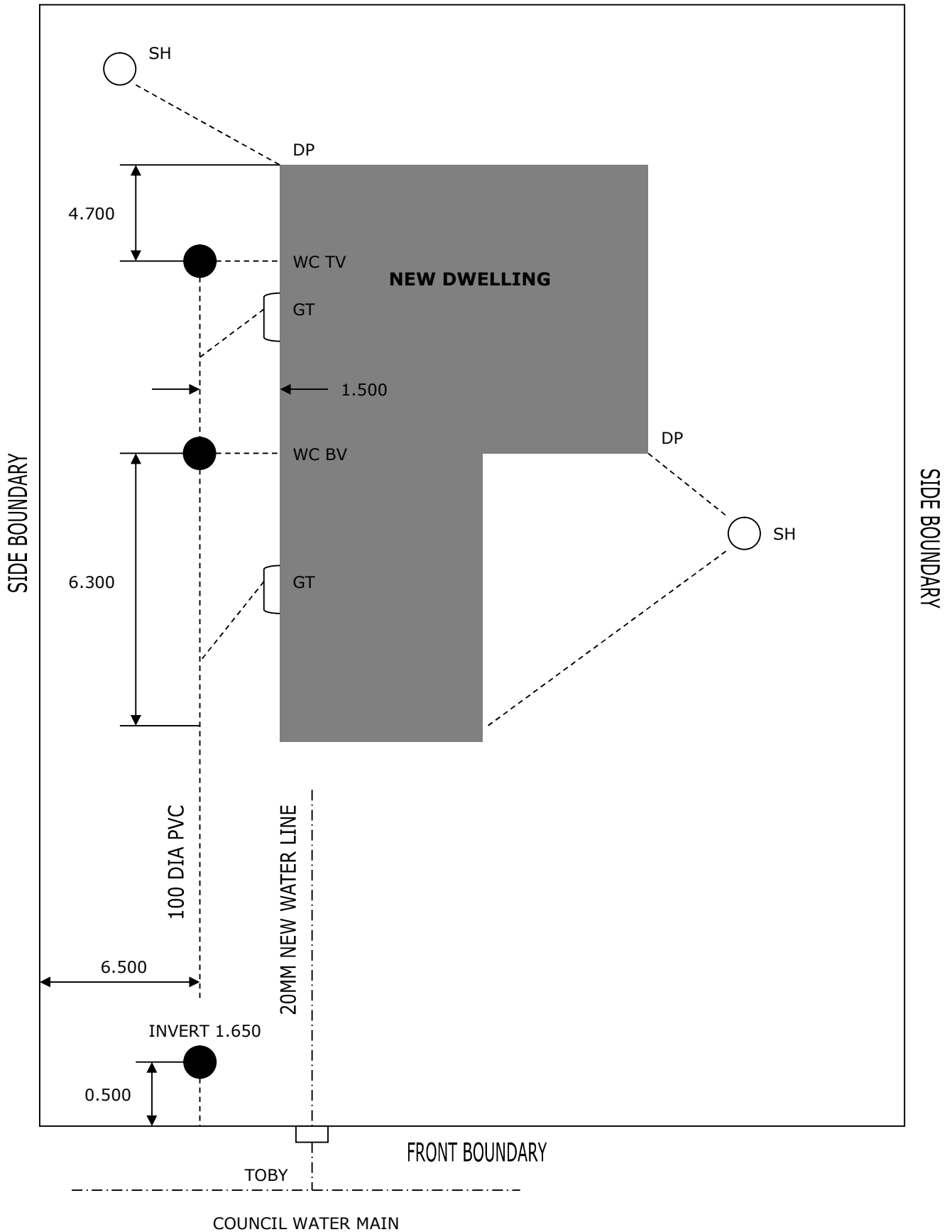
