**The Application:**

This is an application by **Surjit Singh** for a Managers Certificate pursuant to Section 219 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 20th March 2020.

1. The applicant holds the Licence Controller Qualification and the LCQ Bridging Certificate and is employed in licensed premises.
2. The Licensing Inspector has provided a report outlining the applicant's experience in controlling licensed premises and has tested their understanding of their responsibilities as a Manager.
3. Neither the New Zealand Police nor the Licensing Inspector express any concerns about the suitability of the applicant, nor do they oppose the granting of the application. Accordingly, the application is dealt with on the papers.
4. The application and supporting information satisfies the Committee that the criteria we must have regard to, as set out in Section 222 of the Act have been met.

**Decision of the Taupō District Licensing Committee:**

The District Licensing Committee Commissioner, acting pursuant to the Sale and Supply of Alcohol Act 2012 grants the application by **Surjit Singh** for a Manager's Certificate.

The applicant holds an Indian passport, and has an Interim NZ Work Visa, as his previous visa expired as at 14 March 2020. The NZ Work Visa allows the applicant to work as a duty manager for Prater's Supermarket in Taupo.

The certificate is valid for the period of twelve months from the date the certificate is issued.

Section 217 - Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012

**Surjit Singh**

Certificate Number: **20/CERT/2598/2020**

is authorised to manage any licensed premises in respect of which a licence is in force.

Subject to the requirements of the Act relating to fees and to the provisions of the Act relating to the suspension and cancellation of manager's certificates, this certificate shall continue in force:

a) Either:

1. Until the close of the period for which it was last renewed; or
2. If it has never been renewed, until the close of the period of twelve months after the day it was issued; but

b) If an application for the renewal of the certificate is duly made before the certificate would otherwise expire, either:

1. Until the close of the period of three years after the period for which it was last renewed; or
2. If it has never been renewed, until the close of the period of four years after the day it was issued.

This Certificate is subject to the following undertaking:

- The applicant holds an Indian passport, and has an Interim NZ Work Visa, as his previous visa expired as at 14 March 2020. The NZ Work Visa allows the applicant to work as a duty manager for Prater's Supermarket in Taupo.

This certificate expires on **22 April 2021** if not renewed.
