

IN THE MATTER of the Sale and Supply of Alcohol Act 2012 (the Act)

AND

IN THE MATTER of an application by Simon Dickie Adventures Limited for a new ON licence (for Conveyance) pursuant to Section 100 of the Sale and Supply of Alcohol Act 2012 in respect of the premises situated at **Berth 12, Taupo Boat Harbour, Ferry Road, Taupo** and known as "Regal Flyer"

The Application:

This is an application by Simon Dickie Adventures Limited for an On Licence for Conveyance in respect of vessel based at Berth 12, Taupo Boat Harbour, Ferry Road, Taupo and journeying on Lake Taupo, known as "Regal Flyer". It was formally received by the Taupō District Licensing Committee on 15th October 2019. The general nature of the business to be undertaken is that of Conveyance (Boat).

The application was duly advertised in the Taupo Times newspaper on the 12th & 19th of November 2019 and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Reasons for the Decision:

The applicant is an experienced licensee and holds a number of other conveyance style licences for vessels in his fleet. A certificated manager will be on duty whenever there is to be the sale and supply of alcohol on board the vessel.


The Police and Medical Officer of Health reports raise no matters in opposition.

The Decision:

We are satisfied as to the matters to which we must have regard as set out in the Act and we grant the applicant an On Licence authorising the sale and supply of alcohol for consumption on the conveyance, to any person present on the vessel and to allow the consumption of alcohol on the conveyance by any such person.

The licence shall be subjected to specific conditions as detailed in the attached licence.

ON-LICENCE

(for Conveyance)

Sections 14 to 16 and 64 of the Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012, **SIMON DICKIE ADVENTURES LIMITED** is authorised to sell and supply alcohol, on the vessel known as "**Regal Flyer**" based at Berth 12, Taupo Boat Harbour, Ferry Road, Taupo and journeying on Lake Taupo, to any person present on the vessel and to allow the consumption of alcohol on the conveyance by any such person.

CONDITIONS

This licence is subject to the following conditions:

1. Alcohol may be sold or supplied for consumption on the premises only on the following days and hours: **Monday to Sunday from 8.00am to 12 midnight.**
2. No alcohol is to be sold or supplied on the premises on Good Friday, Easter Sunday, Christmas Day or before 1.00pm on Anzac Day to any person other than a person who is on the premises to dine.
3. Free drinking water is to be available at all times when the conveyance is open for the sale and supply of alcohol.
4. The Licensee must have available for consumption on the premises, at all times when the premises are open for the sale and supply of alcohol, a reasonable range of non-alcoholic and low-alcohol beverages.
5. Food must be available for consumption on the premises at all times the premises are open for the sale and supply of alcohol, in accordance with the sample menu supplied with the application for this licence or menu variations of a similar range and standard. Menus must be visible and food should be actively promoted.
6. The licensee must ensure that signs are prominently displayed within the licensed conveyance detailing information regarding alternative forms of transport from the conveyance.
7. A properly appointed certificated or Acting or Temporary Manager must be on duty at all times when the premises are open for the sale and supply of alcohol, and their full name must be on a sign prominently displayed in the premises.
8. The Licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the supply of alcohol to minors and the complete prohibition on sales to intoxicated persons.

THE LICENSED PREMISES

The sale, supply or consumption of alcohol is authorised on the vessel generally. The premises based at Berth 12, Taupo Boat Harbour, Ferry Road, Taupo, are more precisely identified as outlined in a plan date stamped as received by the Taupo District Licensing Committee on 15 October 2019.

DISPLAY OF LICENCE AND PRINCIPAL ENTRANCE

A copy of this licence must be displayed at the principal entrance to the premises. The principal entrance is accessed from the bow of the vessel.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence continues in force -

- (a) Until the close of the period of 1 year commencing with the date of its issue; or
- (b) If an application for the renewal of the licence is duly made, until the application is determined; or
- (c) If the licence is renewed, until the close of the period of 3 years after the period for which it was renewed.

This licence expires on 17 December 2020 unless further renewed
