**The Application:**

This is an application by Inno Joenel Jacinto Bayoguing Elumba for the renewal of a Managers Certificate pursuant to Section 224 of the Sale and Supply of Alcohol Act 2012. It was formally received by the Taupō District Licensing Committee on 4th May 2020.

1. The applicant holds the Licence Controller Qualification and is employed in licensed premises.
