

IN THE MATTER of the Sale and Supply of Alcohol Act 2012

AND

IN THE MATTER of an application by Lion Liquor Retail Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **86 Roberts Street, Taupo** and known as "**Liquor King Taupo**".

THE APPLICATION

This is an application by **Lion Liquor Retail Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Liquor King Taupo**, situated at **86 Roberts Street, Taupo**.

The applicant is the holder of an **Off Licence** [20/OFF/0013/2016] which was last renewed by the Taupō District Licensing Committee on 13 October 2016.

The application was duly advertised on the Taupo District Council website from 6 October 2019 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

REASONS FOR THE DECISION

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. The hours are reasonable, and the host responsibility practices appear sound.

THE DECISION

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

I direct that a notice of renewal and a replacement licence be issued.

Notice of Renewal of Off Licence

Section 135, Sale and Supply of Alcohol Act 2012

To: Lion Liquor Retail Limited

Licence **20/OFF/0013/2019** replacing licence **20/OFF/0013/2016**

The Off Licence in respect of the premises situated at 86 Roberts Street, Taupo known as “**Liquor King Taupo**” is renewed.

The present conditions of the licence shall continue to apply.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—

- until the close of the period for which it is renewed; or
- if an application for the renewal of the licence is duly made before it would otherwise expire, until the close of the period of 3 years after the period for which it is renewed.
