

**IN THE MATTER** of the Sale and Supply of Alcohol Act 2012

**AND**

**IN THE MATTER** of an application by Global Beverages NZ Limited for the renewal of a licence pursuant to Section 127 of the Act in respect of the premises situated at **118 Spa Road, Taupo** and known as "**Whiskey and More**".

#### **THE APPLICATION**

This is an application by **Global Beverages NZ Limited** for the renewal of an **Off Licence** in respect of the Licensed Premises known as **Whiskey and More**, situated at **118 Spa Road, Taupo**.

The applicant is the holder of an **Off Licence** 20/OFF/0076/2018 which was last renewed by the Taupō District Licensing Committee on 4<sup>th</sup> September 2018.

The application was duly advertised on the Taupo District Council website from 21 July 2021 for a period of 10 days and no objection or notice of desire to be heard has been received. Display of the public notice has been carried out in the terms of the Sale and Supply of Alcohol Act 2012 by the licensee and no objections were lodged by any members of the public.

The Inspector has provided a comprehensive report that outlines the safe and responsible operation of this licence for many years.

#### **REASONS FOR THE DECISION**

The applicant is a proven operator and has not come to notice in an adverse manner for any of the reporting agencies. Two certificated managers are attached to the business.

#### **THE DECISION**

We are satisfied as to the matters to which we must have regard as set out in the Act and approve the renewal of the licence for three years on the same conditions as previously granted by the Taupo District Licensing Committee.

We refresh condition 4 to be legally accurate. The licensee must have a least one certificated manager appointed to the business, but they do not need to be physically 'on duty' as with other off-licensed premises.

I direct that a notice of renewal and a replacement licence be issued.

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, the licence continues in force—
